Hazards of Low Level Radioactivity

Low Level radioactivity weakens the immune system. The global fertility rate has dropped to nearly half of what it was in 1955. Large-scale breakdown of the protective ozone layer in the stratosphere initiated in 1958 by high atmosphere bomb tests continues due to radiation released from nuclear power plants and reprocessing plants. Mutations have caused the appearance of strange new diseases. The percentage of oxygen in the air is down from 21 percent to about 19 percent. Following is a survey of the hazards of low level radioactivity.

Infertility

The global fertility rate has dropped by nearly half since 1955! The cumulative effects of radiation-caused infertility raise the possibility of gradual human extinction. We may be concerned about the Pentagon backed globalization of trade, but there are other worries. This trade scenario to sell more goods is built on the quicksand assumption that there will continue to be consumers!

Projected sales and quarterly growth are predicated on one variable that can no longer be counted on—living consumers. Escalating infertility in the United States has forced couples to turn to the fast emerging new world of assisted reproduction and pre-made embryos in ever-growing numbers. A front page *New York Times* article of November 23, 1997, "Clinics Selling Embryos Made for Adoption" explains that "anguished infertile couples are more than willing to pay for whatever infertility clinics can offer."

Fear of the "population bomb" of the 1960's has turned into the "birth dearth" of the 1990's. The so-called replacement rate is 2.1 children, which is needed to keep the population from falling. The

current fertility rate in the developed nations is 1.6 children per woman. In the less developed countries it is now 3 and falling. United States rates have been below replacement for the last 25 years.

From 1950 to 1955 the global fertility rate was 5. Today the total fertility rate is 2.8. According to a 1996 United Nations report, "World Population prospects: The 1996 Revision," fifty one nations with 44 percent of the world's people are now at or below the replacement requirements. Dr. John Gofman, eminent scientist, medical doctor and spokesman against the hazards of nuclear power, explained in the 1970's in his book *Population Control Through Nuclear Pollution* "that the worry about over-population would become a non-worry due to radioactivity." This is confirmed in the decline in fertility among those born at the time of atmospheric bomb testing between 1955-1963.

Dr. Rosalie Bertell, mathematician, epidemiologist and President of International Institute of Concern for Public Health has been researching infertility for some years and feels it is the "cutting edge" of radiation health damage, surpassing immune damage in the extent of its implications, as it raises the possibility of human extinction. In response to questions on the status of this research, Dr. Bertell writes in a personal correspondence (November 1997):

We found in Kerala, India, that when comparing people matched for socioeconomic status, class, religion, occupation and life style, those living on the high radiation back-

ground (300 to 3000 mrad per year) had twice the rate of couples who want children but are unable to have children, than we found for those living on the normal background soil (below 300 mrad per year). This has been released in press statements but it is not published. You will have to take my word for it.

The Baby Boomers are the group born in the USA after the war, the years 1945 through 1963, and these are the years of atmospheric bomb testing as well as the start of the nuclear power industry. They show a high rate of immune related diseases and also an increasing rate of infertility. Data from the U.S. Public Health Service illustrate the difference between fertility in the Baby Boomers and those who are called Pre-Baby Boomers with regard to the percentage of women infertile by age. ("Reproductive Impairments Among Married Couples United States," U.S. Public Health Service, Washington, DC, December 1982). Two surveys, in 1965 and 1976, showed that the percent of infertility in the Baby Boomers increased, and the percent of infertility of the Pre-Baby Boomers, born before bomb testing and nuclear power, decreased.

Weakened Immunity

On the correlation between low dose radiation and weakened immunity, radiation physicist, Dr. Ernest Sternglass, states in a 1986 article:

It appears that perhaps the most serious unanticipated effects of fallout is long-term, persistent immune deficiency ... It can weaken the immune defenses of the body at very low total doses leading to unexpectedly large increases in infectious diseases and cancers. (*Int. J. Biosocial Res.*, July 1986, p. 18)

Initially zealous misrepresentation of the facts led the public to understand that small amounts of radia-

tion were of no special concern. Yet these low levels are exactly the cause of weak immunity and resulting diseases.

Authorities couldn't ignore emerging data and, in December 1989, the government-sponsored National Academy of Sciences stated in a report titled "Biological Effects of Radiation" that there was no safe level of radiation. Low protracted doses of radiation cause physiological damage through the formation of free radicals. A free radical is a molecule with an imbalance in electrons which can destabilize other molecules resulting in cellular damage and disease. In high, short doses like the Hiroshima bomb blast, radiation primarily causes direct damage to the nucleus of cells where the genes are located that control the functioning of the cell. In contrast, low doses acting continuously over time produce their damage indirectly through the generation of free radicals, which destroy cell-membranes hundreds to thousands of times more efficiently than might be expected in calculations related to high-dose damage.

The everyday amount of radiation that is released as part of the normal operation of the world's 400 nuclear power plants is a very grave concern. Nuclear power plants must have releases in order to function, and these releases, even though they may be partially filtered, allow radiation to go into our air and drinking water and onto farmland and into our food.

The everyday releases of low-level radioactivity by nuclear power plants has been found to cause several kinds of health damage including premature births, congenital defects, infant mortality, mental retardation, heart ailments, arthritis, diabetes, allergies, asthma, cancer, genetic damage and chronic fatigue syndrome. It has been linked to



previously unknown infectious diseases, and the resurgence of old ones by damaging the developing white blood cells originating in the bone marrow and thus weakening the immune system. Dr. Sternglass conjectures what could happen (Interview in *National Catholic Reporter*, October 16, 1997):

With countless thousands of persons having a weaker and weaker immune system as the result of increasing radioactive contamination of the air and food chain, an AIDS mutation-like disease could become a new Black Plague. It's not inconceivable that entire nations could be decimated.

Mutated Bacteria And Viruses

It is well known that radiation can cause mutations in bacteria and viruses. Andrei Sakharov, the famous Russian physicist, described in his 1992 *Memoirs* that even at low levels radiation could increase mutations of bacteria and viruses. His predictions, which were originally made in 1958, have come true and we are seeing new ailments such as Reyes Syndrome, which first appeared in 1963, and Legionnaire's Disease, which is caused by a bacteria that was not threatening prior to 1976. AIDS may be related to a mutated virus combined with a weakened immunity in a generation born after the first nuclear weapons were detonated.

Of particular interest is Lyme Disease, which first appeared in 1975 near the Millstone and Haddam Neck nuclear power plants in Connecticut. As Dr. Jay Gould in *Deadly Deceit* (1990, Four Walls Eight Windows) writes:

In 1975 there were 59 cases of Lyme Disease recorded; in 1985 the number increased to 863, mainly in the two counties of Middlesex and New London, CT near the Millstone Nuclear Power Plant. Just as increases in cancer may be linked to the huge radiation release from Millstone in 1975, so too may be the tick-borne Lyme Disease epidemic. The Lyme Disease is carried by a spirochete that had not been as harmful to humans prior to 1975. It is well known that radiation can cause mutations in bacteria. The enormous 1975 Millstone radiation release may have caused just such a mutation in the tick-borne spirochete.

Thus we have a double challenge—the weaker immune system and the new diseases resulting from mutated pathogens. Dr. Ernest Sternglass explains (“The Implications of Chernobyl for Human Health,” *International Journal of Biosocial Research*, July 1986):

When the radiation from such isotopes as strontium-89 and 90 in the bone marrow mutates an existing virus that invades the T-cells of the immune system and kills them in the process of replication, the stage is set for the complete collapse of the immune defenses, and resulting death from opportunistic infections or cancer.

Loss Of Oxygen Globally

Walter Russell, a visionary artist and scientist, predicted in his 1957 book *Atomic Suicide?* that due to man-made radioactivity we would experience a loss of oxygen in the air that we breathe. In a similar way to the predictions of Andrei Sakharov in the 1950s, Walter Russell's foresight is now coming true. Our current oxygen resources are low. The percentage of oxygen in the air is down to about 19 percent. (*BioTech News* 1997) The expected amount is 21 percent oxygen. Some experts say that we may have originally evolved in an atmosphere of 38 percent oxygen. But now, due to the depletion of our two sources of oxygen production, forests and ocean plankton, heavily industrialized areas have measurements of oxygen as low as 12-15%. This oxygen-depleted condition is a contributing cause of the generalized lack of well-being that many are experiencing.

And it does not look good for the future. We need oxygen to live! Trees and green plants provide about half of our oxygen, and plankton provide the other half. Phytoplankton, which are the base of the marine food chain, is declining. Various studies confirm that plankton in parts of the Antarctic Ocean is declining up to 12 percent. (S. Weiler. Testimony to Senate Commerce Committee, November 15, 1991) Trees absorb radioactive carbon-14 in place of stable forms of carbon and in this way they are gradually killed.

In *The Petkau Effect*, Ralph Graeb tells how radioactivity has harmed trees and forests:

It is assumed that the decisive physiological damage resulting in current forest death must have begun during the 1950s. This is depicted in a reduction in density and width of tree rings, and in reduced growth, which is true in the Northern Hemisphere and in the Himalayas.... Neither aging, location, nor climate can be considered as the possible sole cause of damage.... The growth ring of a tree shows exactly what effects the tree has experienced, both in terms of time and seriousness.... During the 1950s and 1960s, there must have been a global wave of air pollution which caused the initial damage.

The author speculates that it could not be just the usual chemicals which are damaging the trees. These trees are mainly within the 30th to 60th parallels of northern latitude. He explains: “This zone contains the most nuclear power plants—over 300—and almost all nuclear reprocessing centers. Also, the vast majority of nuclear weapons tests occurred in this area.”

Ozone Breakdown

The protective layer of ozone around the Earth filters solar and cosmic rays from reaching our planet. Ozone surrounds the Earth in a layer between six and thirty miles above sea level. It is formed when light rays strike

molecules of oxygen, and cause them to break into two separate oxygen atoms. An atom of oxygen then combines with a molecule of oxygen and forms ozone. It breaks down again and then recombines again. And so on; unless something interferes with it.

August 1954: "It will not take many years to utterly destroy the encircling protective walls which surround this planet and protect the Earth from burning up by the sun's hot rays." (Walter Russell, Newsletter of the University of Science and Philosophy)

1957: Walter Russell publishes his book *Atomic Suicide?* whose principle message is that the development of the nuclear weaponry and nuclear industry, if it continues, will eventually destroy the planet's oxygen. He wrote: "The element of surprise which could delay the discovery of the great danger, and thus allow more plutonium piles to come into existence, is the fact that scientists are looking near the ground for fallout dangers. The greatest radioactive dangers are accumulating from eight to twelve miles up in the stratosphere. The upper atmosphere is already charged with death-dealing radioactivity, for which it has not yet sent us the bill. It is slowly coming and we will have to pay for it in another century, even if atomic energy plants ceased today." Later in the book, Russell predicted that these effects of radiation would not be noticed until the late seventies.

1982 and 1984: Two German reports cite that radioactive krypton, which is released in the daily operation of nuclear plants and through the reprocessing of used reactor fuel elements, is affecting the distribution of the electric fields in the atmosphere.

1984: A team of British scientists find an ozone hole over the Antarctic larger than the Continental U.S.

1987: The ozone hole is twice as large as the U.S. It is discovered that ozone is not diminishing just over the south pole but globally.

March 1988: The ozone hole makes headlines.

1987-88: The consensus of opinion says that various man-made chemicals are the sole cause of ozone breakdown; especially compounds of chlorine (CFC's) and bromine (halon fire extinguishers) and a lot of talk about hair spray and refrigerators. A leading authority on the ozone problem, NASA's Dr. Robert Watson, admitted many scientists were "baffled" by findings of ozone depletion even in areas where CFC's action was negligible. He called the extent of the hole's growth "absolutely unexpected." [see NASA box, page 6.]

April 6, 1989: *The Washington Post*: "Scientists reported yesterday that for the first time they have detected an increase in "biologically relevant" levels of ultraviolet radiation reaching the ground as a result of the ozone hole over the Antarctica. This is the first indication that the depletion of ozone is beginning to cause the potentially harmful effect that has long been predicted."

Late 1990: University of California researchers publish their findings that phytoplankton are reproducing less profusely than before. Observing the plankton in the Belingshausen Sea they found that increased UV appears to be suppressing the phytoplankton's productivity by 6 to 12%.

1992: Both NASA and the World Meteorological Society reported 10 to 25 percent ozone depletion measured over the northern United States, Canada, Europe and the Antarctica (ozone hole being three times the size of the United States).

1994: An article in a German journal *Strahlentelex* (March 3, 1994) explains that the nuclear industry is responsible for the ozone hole. The authors, Giebel and Sternglass, explain that radioactive gases like krypton-85 from nuclear plants and from the nuclear fuel recycling plants go up to the stratosphere where they create water droplets from the moisture which in turn form ice crystals on the surface of which the destruction of the ozone by the fluorhydrocarbons is greatly accelerated. A quote from this article explains:

The nuclear industry is responsible for the ozone hole. Radioactive gases like Krypton-85 appear in increasing amounts due to the bomb tests, releases and accidents at nuclear reactors and especially from the nuclear fuel recycling plants. Krypton-85 goes up to the stratosphere where it creates ice crystals which catalytically enhance the destruction of ozone by the fluorhydrocarbons.

(Note: Krypton-85 has a half-life of 10.7 years and a whole life of 217 years. "The ozone layer, if it disappears, disappears for all of us." — Isaac Asimov)

1994-95: Hawaii reached its lowest level of ozone on record. The U.S. National Oceanic and Atmospheric Administration announced a 40% increase in dangerous ultraviolet light on the Big Island.

March 1996: The World Meteorological Agency reports "the extremely worrying" development of an unprecedented 45 percent ozone thinning over Greenland, Scandinavia and Western Siberia.

Summer 1997: Research from the Antarctic Marine Living Resources program find "krill abundance in the Antarctic Peninsula region is down 60 to 90 percent since the early 1980s."

Solutions

The other side of technology can save us. We could shift from polluting energy sources. All that is required is scientific and financial support for the non-polluting energy waiting in the wings to end our reliance on nuclear energy and oil and coal. Although the price of solar energy has declined over the last few years, how could it be competitive with the enormous monetary support nuclear power has had in the form of subsidies, tax breaks and insurance coverage by the government?

The United States spends nearly \$60 billion a year to defend the \$30 billion of oil we extract in the Persian Gulf area. This price is too high, and more so when the human suffering from thousands of Gulf War soldiers brutally sick with Gulf War Syndrome are factored in.

Let's use solar panels and electric vehicles to cancel out this dollar extravagaza. Surely \$60 billion could help renewable energies get out to the public. Solar, thermal, photovoltaic, wind, biomass, hydro, earth energy and other benign renewable technologies are ready and waiting. Working models exist which could be refined and rapidly spread around the world at affordable cost. Let technology be put to some use that makes sense! In searching for new energy sources, some inventors have revealed that space is filled with motion—the quantum fluctuations within the atom and between the stars—and that this energy could be converted into electricity. Orthodox scientists have overlooked the vacuum of space and that it might be utilized for energy because they have not realized it consists of pure massless charge.

Instead of being blinded by traditional ideas, let us look into the spectrum of energy sources waiting to be harnessed to make usable physical energy. Once we install clean energies, radioactive waste remains a vast challenge. United States' plans to transport radioactive waste in thousands of shipments across the country to Nevada and to deregulate radioactive waste and use it in commercial products do not make sense! There are other possible solutions. One energy technology that might offer hope is transmutation. Traditional science says this is not possible. However, in recent years, experiments by certain labs have been replicated and several patents granted. Transmutation

is, in this application, used to describe the conversion of radioactive elements into other radioactive elements with shorter life spans, or into non-radioactive elements. In some cases the process may change the radioactive element into another element with a shorter half-life, so that the necessary storage time is reduced. In other cases the element itself would be changed.

If all nuclear power production were stopped and scientists switched over to study the clean-up, and the very available renewable energies were brought into place, we might have a chance to save the Earth as a habitat for Life. Of course, we will have to re-mineralize the soil, quadruple plant life for absorbing CO2 and making oxygen, and stop using meat as a protein source because it requires the abuse of so much land and water.

The Congress of the United States has served the corporate gang since the mid-1970's, has exploited Nature and humans, impoverished the people who are in a state of biological degeneration, and ruined the land with the huge loss of topsoil, bankrupted the government and allowed the perpetration of radioactive contamination all over the Earth.

If enough people move beyond denial and disinformation, if enough people move beyond rage and resentment, if enough people wake up, unite and take action—then we can affect changes. Claim your right to clean water and air and food. Our future is a matter of choice. We each have a role to play.*

The power for many NASA satellites, as well as the U.S. military's new line of space weapons, Theater Missile Defense (TMD) and Theater High Altitude Air Defense (THAAD), is plutonium-238.

As Karl Grossman notes in *The Wrong Stuff*, "the U.S. military wants nuclear-powered weapons in space and that's been a key reason why NASA has been insisting on using nuclear power in space—even when solar power would suffice." A German company has shown that it can make solar panels for space craft at a very economical cost. Instead, the U.S. buys plutonium-238 from Russia at an exorbitant cost, and the U.S. is even considering making plutonium again. As Grossman states, the launch record

for Lockheed Martin's Titan-4, which carried 72.3 pounds of plutonium on the Cassini space probe, is 1 in 10. That's one catastrophic accident for every ten launches. One of these blow-ups will inevitably contain enough plutonium to kill thousands, if not millions of people, and make millions more die a slow horrible death. If Cassini had exploded, NASA speculated that "approximately 5 billion of the world population could receive 99 percent or more of radiation exposure."

The most serious U.S. space mission accident occurred in 1964 with the crash of a satellite containing the SNAP-9A plutonium power system. This accident spread 2.1 pounds of plutonium into the high atmosphere. Dr. John Gofman of UCAL Berkeley connects this little known accident to a worldwide increase in lung cancer. In

addition, in 1978 a Soviet satellite crashed into the Northwest Territories of Canada scattering nuclear debris over a vast area. Again in 1996, the Russian Mars space probe carrying a half pound of plutonium crash-landed somewhere in Chile and Bolivia, leaving its contaminants over a wide area. Who is behind the push for plutonium powered space vehicles? As Grossman points out, all you have to do is follow the money. Who makes money on the use of nuclear devices in space? Companies like General Electric, Lockheed Martin, Los Alamos Laboratories and Oak Ridge Laboratories have long lobbied the government to use their plutonium systems in space.*

Stoned By Moss

"Accidental" Proof of Damage by Emotional Telepathy Experimentation

In mid-November of 1999 I was carrying on an email correspondence about neo-tech physics, shamanism and related topics. This was a fluctuating situation of flip philosophical replies to copy boxes filled with unknown persons and attached to a few neo-tech mailing lists. Suddenly into the central email arena lept the messages of a respondent claiming to be a woman who had been subjected to abusive "mind control" research some years ago at UCLA by Dr. Thelma Moss.

I had done some prior research into medical and academic "mind control" situations and knew that such programs existed elsewhere. I had not heard of the experiments conducted in 1967 and 1968 at UCLA's Neuropsychiatric Institute by Assistant Professor of Medical Psychology, Dr. Thelma Moss. But there were aspects of the email pleas for assistance from Gail W. which deeply troubled me based on my prior research. I decided to ask some questions.

It occurred to me that some of the symptoms—involving uncontrolled and disturbing obsession with violent premonitions—resembled the landscape of a psyche opened by LSD. At the time I asked my initial questions, I did not know that Dr. Moss had experimented with LSD in certain situations. I was guessing. But the respondent, Gail W, had a surprising answer. She claimed not to be affected at all by the LSD she had tried socially years ago. After a bit of probing, she did recall that she had been using antihistamines for allergy at the time she was involved in "healing research" with Dr. Moss. Antihistamines can also open the doors of associative and non-sequential perception in sensitive subjects. But Gail W. was not aware of having been given any consciousness-altering substances. Rather, she felt that something mysterious and damaging had happened to her while she was listening to relaxation

tapes and doing "kundalini" exercises as part of these experiments. As Gail W. wrote by email:

I was recruited into the experiments at UCLA under the most casual of circumstances. I was not a student at UCLA. I had just moved to LA and was producing science stories at KPFFK radio. Dr. Thelma Moss was conducting supposedly psychic research (which was ongoing) in the basement of the Neuropsychiatric Institute. The soon to be mother-in-law of my former college roommate and another woman that I trusted, Ilene M., just said that I fit the model of what they were looking for in her continuing research.

Furthermore, it was to have been potentially helpful, since they were going to have healers work on my allergies and induce self-healing abilities in me. They induced kundalini in me. They used some form of directed energy to zap my upper abdomen and then like a cork popping off a champagne bottle the kundalini just came flowing out of my head and hands. Thereafter, it rose from the root of my spine up through my head and out of my hands. It actually worked as a form of operant conditioning. If I thought pleasant, constructive thoughts this bliss-filled orgasmic feeling would increase. If my positive thoughts diminished, so did the bliss. They also had me listen to relaxation tapes which knocked me out cold in about three minutes. But my allergies did not improve. In fact, they got worse. At the time I was unaware of experiments in

the same vein that were being conducted to cause mast cells to be released which produced false allergies, or exacerbated real ones. I developed giant hives. At this point it is unclear to me whether I have allergies at all given this capability.

After her initial, profoundly disturbing experience, Gail W. corresponded with a number of persons who had experienced and/or researched "mind control" in other more austere situations not oriented toward teaching self-healing. Thus her correspondence is understandably peppered with references to "mind control technology." But there is actually no medical evidence or corroborating evidence from available scientific journals that Gail W. (or anyone else) was subjected to deliberate electronic interference at UCLA. In fact, the mental states of "speeding," increased heart and metabolic rate associated with the stimulation of the adrenal cortex, as reported by Dr. Andrija Puharich in his studies of the effects of 11-18 Hz ELF (extremely low frequency) electronic radiation on cognition during the 1970s (under various auspices), are not exactly the symptoms which most trouble Gail W.

There is, however, real evidence that Gail W. was actually part of the research that Dr. Thelma Moss conducted at UCLA. Most significantly, Gail's descriptions of the lab and of the general atmosphere of the experiments as given in email exactly corresponds to the description of the lab and of Dr. Moss's orientation given in the book *Haunted Ladies*, written in 1975 by Antoinette May. Of course, Gail W's description is biased toward her view of the circumstances and is not the measured description of a journalist writing for commercial publication. So this following description is quite evidential as it does not appear to be copied verbatim from any of the printed accounts of the lab:

At this point I had never heard of Dr. L. Jolyon West, [Auth. Note: scientific experiments with LSD] knew next to nothing about Dr. Moss and had never heard of mind control. When people first came into Dr. Moss' lab, they went through a little charade about how low budget they were. Then they were shown the Kirlian photography room, which was about the size of a bathroom darkroom. You couldn't squeeze her whole staff in there if you wanted to. I have given details to several people who were in a position to check these out. Prior to this these facts were unknown. [Auth. Note: Here Gail W. seems unaware of the previously published accounts of Dr. Moss's work which appeared in professional journals.] (1) You had to take a service elevator to get to her lab. The regular elevator didn't go there; (2) the real research was conducted on level C in the basement; (3) at least in my experience, Kirlian photography was not used in the research.

One doctor who has just finished a book was able to uncover her funding by the CIA, which was actually listed in her curriculum vitae -- no big feat. There are several others who were also reportedly in these experiments. It was at this point that I came to realize that I was being remotely accessed. The concept that one could be remotely accessed was entirely foreign to me, and no one explained this to me on an external basis. But somehow the concept was conveyed to me internally by some decent soul. [Auth. Note: See discussion of involuntary emotional telepathy later in this article.] Also, one of the lab assistants turned to me one day and out of the blue said, "If I

were you I'd get as far away from here as possible." At about this time I started to develop CONSTANT precognitive experiences. Obviously, these were being fed to me. Many were very distressing.

There are two sides to this mind-boggling tale and its effect on Gail W. Though the experimenters seem to have left her unwitting and in the dark as to the actual levels of intent moving in her experimental surroundings, this may have been an unexpected result of her natural, clairvoyant sensibility. In the words of Dr. Moss: "A deliberate effort was made to select subjects who believed they had some telepathic faculty." But there was much more going on in the vicinity of the Neuropsychiatric Lab at UCLA than simple hands-on kundalini exercises. As Gail W. accurately commented in her initial correspondence, there was a link to Russia and to the countries of the then Soviet Bloc. One of Gail W's broadcasting jobs, an independent business which she feels was appropriated at the time by persons involved with Russian immigration, involved documentary news from Moscow. In Gail W's words:

Stephan Schwartz of Mobius [Auth. Note: the Navy & CIA-connected Mobius Psychic Research Group] probably knows much more than I would. Also, he knows how David F. and others ran a scam on me and sold my broadcast TV equipment on the black market. There was a Soviet scientist named Viktor Kaprinkin (sp?) who visited in Tucson [the location of the pirated broadcast business] and claimed contact with people from other dimensions. He had a sort of lab set up in the mountains where this allegedly occurred. A very pure soul. Our communication was somewhat stilted as we had to go through a translator . . .

Other of Gail W's connections at that time are politically sensitive and complex, involving criminal allegations by Gail W. which are beyond the scope of this present article on experimental telepathy. Yet the information your present correspondent can dredge from archives for a short article on the experiments of Dr. Thelma Moss does tend to lend credibility to Gail W's basic claims.

The chapter on Thelma Moss in the book *Haunted Ladies* is entitled "Past Mistress at ESPionage." Why this caption? Simply be-

cause it was Thelma Moss who was deeply involved in a form of "emotional telepathy," also tested by Pavlovian-oriented Soviet researchers and Dr. Moss, who participated in the international conference in Prague, Czechoslovakia in 1973 along with scientists from the former USSR and Europe. The purpose of this conference was to develop research on "psychotronics," a then new area of science described in conference literature as "the study of all interactions between man and objects, both animate and inanimate." In 1969, there was a conference at UCLA chaired by I. M. Kogan, chairman of the Bio-Information Section, Popov Institute, Study of Radio Electronics and Communications, and Dr. Moss also lectured at this symposium.

The article "Telepathy and Emotional Stimuli," co-authored by Dr. Thelma Moss and J. A. Gengerelli, appeared in the *Journal of Abnormal Psychology* No. 4 (p. 341-348) in 1967. In this experiment, and in several other "emotional telepathy" experiments conducted by Dr. Thelma Moss in her laboratory at UCLA, as many as 144 respondents were asked to be either "senders" or "receivers." The "senders" were exposed to a multi-media barrage of emotionally arousing stimuli at a specified time and the "receivers" were then asked to record their impressions. The evidence for telepathy in these experiments was above chance and the process was scientifically "controlled" by the use of mannequins in certain of the "sending" sessions. The receivers did not know which of the sessions involved mannequins, and the scores of the receivers demonstrated that they were more accurate when a live person was being barraged by emotional stimuli than when a mannequin was being barraged by the same stimuli.

But there are two interesting codicils to the simple conclusion of "successful emotional telepathy" as achieved by Dr. Moss. One of these, as noted by Dr. Moss at the time, is that the mannequins were observed by a researcher familiar with the emotional stimuli content in order to time the experiment. This observer would be less emotionally affected by such multi-media demonstrations, having participated in the design of these demonstrations. However, a time displacement of stimuli content was noticed in certain "receivers" as if they also "knew" by telepathy the sequence of sessions rather than just the session occurring at the exact time they were asked to focus attention.

The emotional content of several of these multi-media experimental sessions was violent and political in nature while the emotional content of other multi-media sessions was directly sexual or placid in impact. As I was reading the write-up of this experiment, as published in the *Journal of Abnormal Psychology*. I was struck by the similarity of obsessive emotional effects reported by Gail W. to the content of two of the multi-media sessions employed by Dr. Moss, specifically those showing (a) the violence of the John F. Kennedy assassination and (b) the concentration camps and violence of the Nazi regime. Here is a snippet of Gail W's account of the effects she experiences up until the present day:

I began to experience what felt like hot electric needles stuck into the cuticles of my hands and feet, driven into my heels, inside the toes. . . This causes not only the sensation of being stuck with needles 24 hours a day but also the application of very painful shock which reverberates throughout my nervous system.

Note that, as mentioned previously, actual bombardment by subliminal ELF frequencies does not cause these exact symptoms, which are more like the phantom symptoms of direct electric shock by contact with live electrodes. According to Gail W, who sought medical help, a neurologist reported that these symptoms might involve specific areas of the thalamus within which spinothalamic tracts interact or regions where these tracts are convergent. Yes, perhaps. But another explanation might simply be that the emotional idea stimulus "tortures by Nazis" entered her very sensitive mind by the same form of psychic displacement noticed by Dr. Moss in sequential analysis of sessions, and remained there. Another snippet from Gail W's experience is political, and involves precognition. In her words:

The other aspect that is puzzling is that many of these experiences were precognitive. I find myself wondering how they managed to do that. These events were identical to watching a film, only I was the victim in it. In that way I experienced Sadat's murder. On the night that Reagan was shot, I sat up shaking and crying and waiting for the countdown. These events were modeled out perfectly. How did they do it?

Notice that Gail W. attributes what are obviously her own spontaneously perceived episodes of precognition of assassination to "outside sources." This seems on the first glance to be paranoid. But what if Gail W. is partly correct? One of the multi-media "sending sessions" in the Moss experiments at UCLA was the JFK assassination, complete with photo journalism of this tragic event. Notice also that Gail W. reports her inner perceptions are "identical to watching a film." The sessions which Dr. Moss used in her "emotional telepathy" experiments were partly on film.

Here we may be dealing with telepathic "displacement" which goes far beyond what Dr. Thelma Moss might have dreamed in her wildest nightmares. For Gail W. was not aware of being a subject in the emotional telepathy experiments. She does not recall being designated as a "sender" or a "receiver." By her own

account, she was simply in the same lab being programmed with tapes and kundalini stimuli as part of a "self-healing" experiment for which I have found no exact corroborative data in archives—though there are published accounts of Dr. Moss conducting experiments with Kirlian photography and healing of plants.

The specific procedures undertaken to awaken "self-healing" energies in Gail W. must have been part of a

It occurred to me that some of the symptoms - involving uncontrolled and disturbing obsession with violent premonitions - resembled the landscape of a psyche opened by LSD.

very particular experiment which was never published. But this was an experiment which rendered Gail W. extremely passive and receptive whilst listening to tapes and participating in various mental exercises. She does not recall any direct sexual input in the lab and does not claim any sexual abuse with regard to the kundalini exercises. The major problem seems to be that, paradoxically, the attempt to enhance Gail W's ability to heal

herself by the use of her own energy system has resulted in an enhanced perception of phantom physical pain and an enhanced ability to accurately predict political assassinations and natural disasters.

Might the "LSD-like" impressions experienced by Gail W. in conjunction with the research done by Dr. Moss at UCLA's Neuropsychiatric Institute be less due to the antihistamines Gail W. was taking for her allergies than due to a "telepathic contagion" from the LSD-active research into telepathy conducted by Dr. Moss in exactly this same laboratory location but at a different time?

The second codicil to the Moss experiments with "emotional telepathy" seems to be associational displacement in time and space which goes far beyond simple "out of sequence" telepathic reception and into the area of high tech "psychotronics" effects used for mind control and warfare.

At the time of these experiments twenty years ago, Dr. Moss was in touch with Soviet scientists interested in mind-machine interaction, emotional telepathy, and espionage. The idea of warfare and political tension between the USSR, the United States and other countries such as China, who were also doing research into the use of telepathy and telekinesis, strongly permeated the experimental atmosphere surrounding the small laboratory at UCLA. The tragic effect to Gail W., a person who came to this lab for experimental self-healing but was rendered by subliminal telepathic transfer unusually sensitive to phantom pain and violent and traumatic political events, actually demonstrates certain key elements of Dr. Moss's theories about emotional telepathy: (a) the possible displacement in time and space of telepathic effect from one person to another, (b) the power of artificially-induced emotional telepathic projection to impact the receiver as a "real" image, and (c) the possibility of using the impact of these telepathic techniques for psychic warfare and brainwashing.

But witches and sorcerers of all cultures, who use physical and emotional stimuli in the form of costumes, music and bardic poetry or ritual prayer, have known for Millennia that the emotions can be artificially aroused and used to fuel "spell-casting" or specifically-directed thought projection.

Conclusion

Without actually intending to wage war on Gail W. in the lab, Dr. Thelma Moss has demonstrated by accident that subliminally-directed emotional telepathy can be used to disable even the most intelligent and aware individual such as Gail W., the manager of a documentary film studio, causing episodes of psychosomatic illness and phantom pain as well as creating obsessions which render constructive action, such as the prevention of danger anticipated by precognition, extremely difficult or impossible.

Persons working on military, corporate and/or hazardous jobs where split second judgment sometimes is necessary should be trained to recognize the possibility of directed emotional telepathy.

At the time Dr. Moss was conducting her experiments, the KGB was evincing profound interest in the use of psychotronics and emotional telepathy for military purposes. Now that the Soviet intelligence agencies which were active in the heyday of the KGB have been nominally disbanded, unemployed survivors of this secret military organization have vended plutonium, radium and high tech weapons to a variety of small nations and international corporations. There is no reason to feel that ex-KGB adepts have not also vended previously clandestine knowledge of psychotronic and psi-training intelli-

gence procedures to those developing nations and corporations interested in a cheap and fast way to initiate espionage and subliminal mind control.

In this context, perhaps Gail W. can come in the present day to find a transpersonal "reason" for her traumatic experiences, and a means by which her problems can be resolved. By her steadfast insistence on the "reality" of her precognitive and phantom pain experiences, she has opened a small door into what may have become in the present day a significant and hidden agenda involving the directed use of "emotional telepathy" by trained operatives. As an experiment, I ask each reader of this article to send Gail W. an emotionally-telepathic and healing image. It should also be noted here that all mild ELF fields are not

harmful. Like the mind itself, subliminal electrical force has the capacity to heal as well as to shock and, according to the research of Dr. Andrija Puharich, subtle exposure of the body/mind system to 8 Hz ELF can often cause healing effects.*

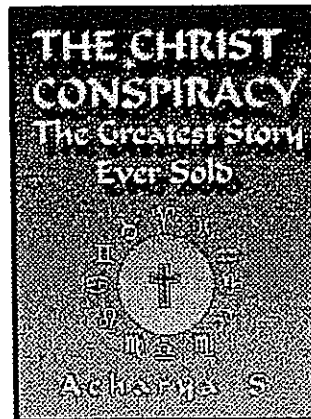

The MIB Enigma

Who are these strangers called Men In Black (MIB)? Continued debate has done little to resolve their ever-increasing mystery. Are they part of our own "Secret Government?" Are they themselves extraterrestrial entities? Often people say that the MIB are Oriental looking. There are even reports that MIB behave more like robots.

What follows are reports and stories so bizarre many of them defy the usual earthly explanations. These stories are about actual UFO sightings and people's harassment by the so-called MIB, including my own experience as a child.

A Craft Sighting and a Stranger

Thinking back at this time in my life, I am continually amazed as more and more of these sightings come to light. As I remember, it was either the summer of 1960 or 1961, at the end of July or the beginning of August, when I experienced my first encounter with a UFO and the MIB. I was about 8 or 9 years old and spent my summers with my aunt, my Uncle Butch, and my cousins, Denise and Darlene (twins) and Butchie in Trappe, Maryland, which is a small town outside of Cambridge.

One evening after we had finished dinner and were cleaning up, Butchie took the trash out. It was about 8:00 and the light was still strong. It had been very hot that day. In fact, there had been a heat wave all week. We were finishing the dishes when Butchie ran in screaming, "There's something flying in the back field. Hurry, come see!" The back field is a baseball field behind the local church where we always played. In fact, it was the only place to play.

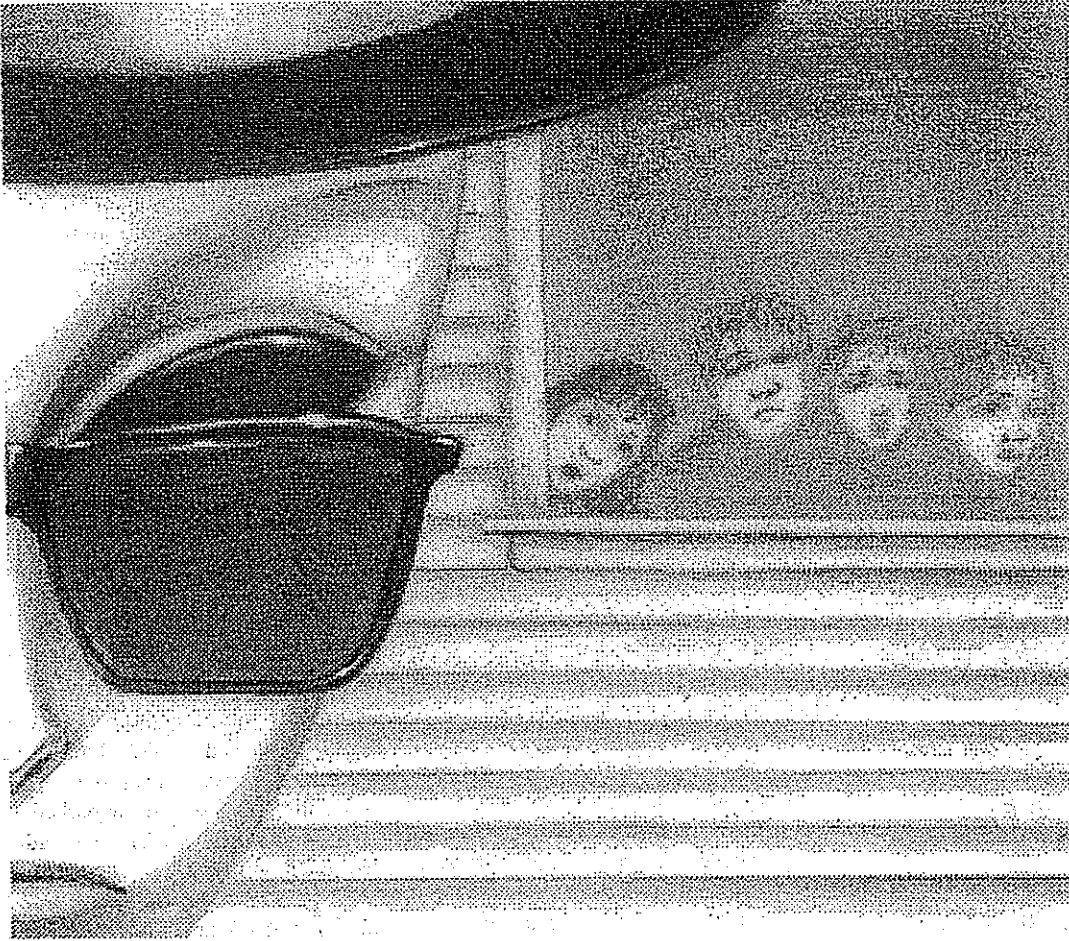
Uncle Butch, Butchie, the girls and I ran out the door, through the back yard and onto the ball field. At first, unsure of what we saw, we just stood there. Being inquisitive, we decided to take a closer look. We walked through the gate to the first base side of the diamond and proceeded to climb on top of the dugout to get a closer look.

It was silver-gray, commonly called pewter. We didn't see any windows or doors or, for that matter, any kind of seams like you would find on a plane. I have seen similar crafts in pictures since that time. It had what looked like three large balls underneath it. The craft was about 90 feet in diameter. It was easy at the time to figure out the size of this craft because it took in the whole baseball diamond. It just hung in mid air. It emanated a very slight hum, almost too quiet to hear. A couple of us reached toward its smooth, metallic sides as it hovered about 10 feet off the ground and nearly 20 feet from where we stood. From the dugout it seemed as though it was sitting in our laps.

We sat rubbing our eyes because it kicked up so much dust. My uncle stood and watched unmoving and silent. We were awed. "What is it? How come there's no sound from something this big?" we asked. A few minutes later the craft lifted up slowly, going straight up into the sky as if filled with helium. It flew up until it was a small point in the clear blue sky, and took off.

People have asked me if we got sunburned, but there were no marks or burns on any of us. I have also been asked about missing time, but every second we stood and marveled at the sight can be accounted for.

My uncle worked for the Marine State Police in Maryland at that time. When



we returned to the house, he called someone to report the sighting. We could hear how excited he was as we all went upstairs. We spent half the night watching out the windows in case the craft returned. When Uncle Butch finished his call he prowled the house like a caged panther. We weren't sure if he was nervous or upset.

When my uncle came home from work the next day, he called all of us together. We sensed something was wrong because he looked and sounded upset. When he started talking we knew we'd better listen. He told us never to talk about what we saw to anyone. We were to keep our mouths shut. "You didn't see anything," he said. He kept repeating, "Do you understand?" while we tried to ask 'How' and 'Why' and get him to listen to us. He was adamant.

Every time we said, "But..." he told us to "Shut up!" We were ordered not to talk to anyone about what we saw or we would be in big trouble. We all agreed that we wouldn't say anything.

Later that day we had a visitor. Uncle Butch ordered us to go inside the house. From inside the house, we saw people walking around out back heading for the baseball field. They were carrying some kind of instruments, but we didn't know what they were. We had never seen anything like them before. They stayed in the back field all day. The following day they returned. We watched them from the windows, finally noticing a strange man just standing there. He wore all black with a black hat that looked too big for his head. This was strange in itself considering how hot it was. He never spoke to anyone. He

just watched. He didn't approach or talk to anyone while we watched. He stood watching everyone else. The next time we looked for him, he'd vanished.

We never knew who ordered Uncle Butch to keep us quiet. He wouldn't tell us then nor at any time, going to his grave with the secret. My experience changed me. I've spent my life reading about other worlds and strange sightings. In 1988, I began to research the subject in earnest.

Who Are They?

Whenever the MIB show up it is apparent they're not just members of a UFO group or curiosity seekers. They look very normal, except for their dark clothing. Their car, if they have one, is usually quite large and seems to appear out of nowhere,

often disappearing as fast as they appear. Their behavior is often eccentric and even threatening at times.

John Keel, author of *The Mothman Prophecies* and *Operation Trojan* talks about the MIB activity in the USA during 1965 and 1967. Keel alleges that he has had nocturnal experiences with these entities.

In one reported case, an individual in civilian clothes, who represented himself as a member of the North America Radar Defense Network (NORAD), demanded and received photographs from a private citizen.

We watched them from the windows, finally noticing a strange man just standing there. He wore all black with a black hat that looked too big for his head.

In another case, someone in Air Force uniform approached local police and other citizens who had sighted a UFO, assembled them in a schoolroom and told them they hadn't seen what they believed they'd seen. They were ordered to keep silent about the sighting.

In one very strange case in September 1976, Dr. Herbert Hopkins was called in on a consult to hypnotize a UFO witness in Maine. Dr. Hopkins was visited by two MIB, one a WIB (Woman In Black). The man seemed to be wearing lip gloss and had lipstick smears on his mouth. He also wore ill-fitting clothes. The woman was physically lopsided. At the conclusion of the usual routine sequence of questions, the MIBs told Dr. Hopkins they had to go since they were running low on energy.

Bob Luca and his wife Betty Andreasson-Luca have often been plagued by government harassment in Connecticut. Since their recent move, things seemed to have been a bit quieter. Bob wrote and told me of one experience he had in the 1980s. Bob relates their story this way:

"In the early 1980s, I think 1983 during the winter, Betty and I decided to take a trip to Florida to visit Betty's sister who lived in Pompano Beach. We got as far as Lake Work, Florida and decided to stop overnight at a campground where we had stayed in the past while vacationing with our camping trailer. We pulled into the Lake Worth campground on Lake Worth Road about half an hour before dark.

As soon as I went into the office, I heard two people talking about a UFO sighting over the campground the night before. Being tired and not wishing to engage in a long conversation, I said nothing. Instead, I paid for our lot and went back to the car. We had a car with fold-down seats that made a reasonably comfortable bed and thought we would settle in for a good night's sleep. In the morning we'd shower and be on our

way. Well, that did not happen.

As we stretched out getting ready to go to sleep, a baseball-sized multi-faceted multi-colored ball of light drifted into the car through the closed driver's door. The ball was illuminated from within and slowly passed through the car from the driver's side to the passenger side. Thinking this was quite unusual, I made a mental note of it and again settled down to sleep.

Later that night, after midnight, I heard a car pull in near us. I looked out the window and was surprised to see a dark Cadillac had pulled up to the rear of our car at a 45-degree angle. Thinking they were probably trying to beat the campground out of the overnight fee, I went back to sleep. I awoke again around 3 a.m. needing to use the restroom. They were about 30 or 40 yards from us.

I exited our car without waking Betty and locked the door behind me. While walking back from the restroom, I noticed the car parked near us was a black four-door Cadillac sedan with familiar yellow New York license plates. As I approached the left rear of the car, all four doors opened at exactly the same time. Four men got out of the car. They were all dressed in black suits with black ties, white shirts and black brimmed hats. They appeared to be Asian. All of them were of very slender build and looked very much alike, almost like brothers. Strangely, I felt no fear or threat from these men, possibly because of their lack of size or body weight.

As I passed the car, still looking at them, they all moved around the car, much as children playing musical chair. When they were all exactly opposite their starting positions, they entered the car and closed all four doors again at exactly the same time. It sounded as though only one door had closed. I got into our car thinking, "Wow, those guys are weird."

Some physical proof of the evening's events was apparent in the morning. First, when I turned on the

radio and the time blinked on, I noticed the digital clock in the car had gained 20 minutes. The previous day it had been in sync with the time given on the radio. Second, the roads in the campground were all laid out like a grid running East-West or North-South. The compass had pointed due north when we parked the night before and now pointed almost due east — a change of almost 90 degrees. The compass never read correctly again. Also, when walking around the car with a hand-held compass, the compass pointed directly to the car as it should, the only exception being the driver's door where the ball of light had come through. When the compass was near the driver's door, it would spin quickly away from the car even at distances of four to five feet away. To this day, electrical engineers I have talked to cannot explain the effects on the compass or the digital clock, except to say perhaps they were subjected to some type of electromagnetic pulse. That is the closest I have ever come to the MIB, and to this day I sure wish I had had the presence of mind to ask them what they were doing."

Changing With The Times?

As most MIB sightings go, MIB are often described just as they are depicted in the movie "Men In Black," starring Tommy Lee Jones and Will Smith, wearing black clothes, sunglasses and driving big black menacing cars. Such sightings were typical in the early 1950s and 1960s, and even into the 1970s. Now there seems to be a new trend to their habits. They are often seen in different colored cars and, of course, impersonating members of a UFO group or some government agency — such as in the following story.

Last year, about February 1999, Sharon's first experience with these individuals was when a silent black

helicopter hovered over her bedroom for about three minutes. She realized it was outside her window because her dog was racing around barking, obviously quite upset. She went outside and right above her house about 40 feet or so was an ominous helicopter. It was black with tinted windows and had very long blades, which were silent. No landing gear was visible. It took off gracefully from its hovering position and flew off towards the naval base on the bay.

In March 1999, Sharon spent the night in a hotel on the beach to get away from all the strangeness occurring around her at that time. She drove to the beach and turned onto the highway that led to Port Arkansas when she noticed another helicopter just like the one that had hovered over her home a month before. Sharon watched as it followed her all the way to the Port Arkansas city limits where it banked right in front of her car and flew off towards the Gulf of Mexico.

Unnerved by the event, Sharon tried to keep her mind on continuing her short journey. She signed into her bungalow and went for a walk along the beach. She thought it odd that she was the only person on the beach.

The beach was dotted with wooden Port-A-Johns. As she passed the third one, she had the eerie feeling of being watched. Sharon kept walking and didn't look around. She began to feel uncomfortable, almost as if she were being watched. She turned around and looked up. Hovering above the third potty station was a helicopter similar to the one that had buzzed her. It was pointed directly at her. The helicopter was utterly silent; the only sound was air whooshing from the whirling blades. Sharon couldn't see inside the darkened windows. Shouting up at the dark, silent craft, she yelled, "You can't do anything to me. I'm protected." She turned around and walked the half-mile back to the bungalow.

Turning around only once, Sharon noted the helicopter had turned toward her and hovered in place. She decided to walk a little faster. Her heart raced.

She then realized if they decided to they could take her then and there. No one would ever know. Sharon's family didn't know where she was staying in Port Arkansas. She walked faster. The helicopter didn't follow her. Instead, it seemed to have 'vanished.' She never saw the direction it took.

When Sharon returned from dinner that night, she called her husband to let him know she had arrived safely. She left a message for him to call her back, waiting an hour before trying to call him again. In the meantime, Sharon turned on her television; it wouldn't work. All she got was static. She turned on her CD player — same thing. Sharon decided to call her husband again, but when she called she got an operator who said her home phone was not a working number. At Sharon's insistence, the operator tried several more times, each time getting the same recording that the number she dialed was not a working number. Sharon asked the operator to try some of her friends, but got the same message.

Finally giving up, Sharon called the front desk to get someone to come and fix the television. The desk clerk seemed very cold. After assuring her that someone would be up shortly, he hung up on her. Sharon remembered her cell phone and called a friend, a fellow experimenter who lived in another state. She got through to his voice mail and left him a message saying that if he had not heard from her by 10:00 in the morning he was to get hold of her husband.

Sharon suddenly felt very sleepy and laid down on one of the beds. When she woke up Sharon thought it was morning. As she came around, she realized she was not in the same bed she'd fallen asleep in and was naked lying on top of the covers. Still very groggy, she looked for her clothes, finding them in the living room on the floor by the front door. She didn't remember taking

them off or leaving them there.

Sharon got dressed in different clothes and checked the time. It was 10:30 p.m. She was confused. When she'd left the message on her friend's voice mail, it had been around 10:00; only 30 minutes had passed. She didn't believe what she was seeing. Sharon walked over to the television and turned it on; it worked. Seinfeld was on, confirming the time. She tried the CD player, and it worked, too. Sharon tried her husband again and got through with no problem. She did not tell him of her strange sleep or mention what had happened so far.

Sharon hung up the phone and finished watching Seinfeld, falling asleep during the next show. When she awakened, Sharon had the feeling she was caught in the grip of a very vivid dream and couldn't shake it. She remembered getting out of bed after falling asleep, walking down the short hallway, and running her fingers along the wall. She walked into the living room where a man, dressed in dark colors, wearing a thin tie and dark glasses, sat on the couch. Another man stood right at the door dressed in the same manner. From here Sharon's memory is unclear. She recalled the prick of a needle and being told, "You will cooperate and not speak of this any more. You will not remember this," and other things, which are not quite clear.

Sharon didn't recall who removed her clothes, but she remembered one of the men placing her in the bed. She seemed very groggy. At this point, her memory – or the dream – ended. Sharon began to believe that the dream was partial memories resurfacing of the first time she'd fallen asleep.

Sharon describes the needle mark on her arm. When she awoke the second time, Sharon expected it to be late, but it was only midnight. She got up, showered, and put on clean night clothes. She turned the television sound way up and finally fell asleep again – this time without incident. The next time she awoke it was 5:00 in the morning.

Sharon went for a walk on the beach, ate breakfast, then called and told her husband she was coming home. On the way back to the city, she realized that she needed to call her friend and let him know she was safe. It was 10:00 a.m. when she called and left a message on his voice mail.

At home later that night, Sharon again contacted her friend. He said he'd gotten the messages one right after the other. Sharon's friend was in law enforcement and his voice mail messages were time stamped with the date and time received. The system never failed, but the messages she sent at 10:00 p.m. didn't get to him until the next morning just before he received the message she was fine and heading home.

Was Sharon's experience another MIB visit? The stranger sitting on the couch in the living room that night in her dream spoke in a droning, monotone voice. The other man by the door had remained silent. Strangely, she remembered vehicles parked outside her home for hours, cars with tinted windows and odd, or sometimes no, license plates. These vehicles were not always black, but rather green, white and red. What really happened that night in Port Arkansas?

Impersonating Others?

In July 1993, a man from an East Coast town had videotaped what looked like the lights of a UFO on his camcorder. He loaned the tape to a UFO group at their request. They provided no identification or a receipt, which all reputable groups offer these days, and the film disappeared without a trace. Later inquiries established that particular UFO group did not exist.

Jenny Randles, investigator and author of numerous books, had a similar experience when a journalist arrived to make a radio program

for the BBC in England. At his insistence, she gave him an important tape recording of an encounter at a military base. He had refused to take a good quality copy instead of the original, but luckily, he was given another better quality copy – not the original he expected to get. The program never appeared. Extensive checks with the BBC failed to identify either him or his work.

The enigma of the so-called Men in Black is almost as much of a mystery as the UFO phenomenon, but does such an agency really exist? When all the evidence is considered, it seems that nearly all aspects of supernatural interest are in some way monitored by an agency that, until now, has remained both faceless and nameless. It remains to be seen if the MIB are part of this agency, or just some elaborate hoax designed to keep the focus off something much more important.

KIDNAPPED!

*Interviews On
the Human
Monitoring of
CE4 Experience*

KARLA TURNER TALKS WITH RANDY KOPPANG AND MELISSA LESLIE

Part 1

Commemorating Dr. Karla Turner's untimely passing, this triad of interviews gives greater exposure to underreported insights from her CE4 (ET abduction) research. Dr. Turner died of cancer January 10, 1996. She pursued CE4 mysteries, both as investigator and one encountering being "taken" (1). Turner's final interview is combined here with data provided via the experiences claimed by two abductees, Melinda Leslie (Part 1) and James Baxter (Part 2). The dialogue with Dr. Turner and Melinda Leslie occurred May 7, 1995.

In our global debate over which social forces will impact most on human futures, ET/UFO data is not even an issue . . . yet. However, in recent years, perhaps a prime obstacle to public recognition of UFO data is the constant stream of paranormal scenarios termed "abduction." The paranormal character of such possible experience is additionally implausible to science and its skeptical demands for scientific verifiability.

The CE4 context in focus here is Ufologically controversial. But it should be easier to corroborate, moreover, if "official disclosure" of UFO reality opens doors for sanctioned inquiry. The goal here is recognizing patterns of data where CE4 experiencers report events apparently having human interference, at times appearing entirely perpetrated by humans. Such evidence abounds. And we make this distinction: possibly encountering ET vs. being kid-

napped, or surveilled and harassed by humans, either by military security or a corporate intelligence command.(2) To be sure, the intent here is not to stereotype ET as good, bad or indifferent; and not to allege guilt, by second guessing the politics of policy-making throughout 50 years of global social deconstructionism.



The UFO community has spawned the controversy to which I refer. A "major theme" of (Katharina Wilson's), *The Alien Jigsaw* is (her) "determined rebellion against... the typical abduction scenario (reported by) major... researchers... (whose view of) elements that don't

fit into commonly repeated patterns don't deserve inclusion in the literature."(3) Ms. Wilson believes "it's going to take a lot of different researchers, each with a different focus, to pull all of this information together," since CE4s may comprise "teaching dreams, visions, alien theatrics and shades of government involvement."(4)

In the growing body of CE4 literature, reports of human/governmental interference in individual experiences would be deemed "atypical."(5) Yet, the following cases do so: Leah Haley, Christa Tilton, Diane Sanchez, Pam Hamilton, Karla Turner and husband Casey, Kim Carlsberg, Katharina Wilson, Melinda Leslie, Lori Lingenfelter, Licia Davidson, James Baxter, Bette Andreasson-Luca and husband Bob, Beth Collins, Steve Neill, Anna Jamerson, Whitley Strieber, Larry Warren, Debbie Jordan and others. Most of these case histories are well documented in available books.

Fifty years of recent history reveals academic/scientific rejection of unbiased inquiry into "typical" UFO data, culminating as evidence of institutionalized denial and,

therefore, pop-media distortions of the facts. Thus, by grounding an area of UFO research in simple terms of exclusively human affairs, we tend to broaden our collective perception, lending credibility to routinely reported patterns of paranormal experience implicitly; e.g., the growing corpus of revisionist history regarding the parapsychology of post-quantum intelligence-gathering by the National Security State. ET is not the exclusive subject of Ufology. An exposé of the following unforeseen circumstances can lead to an interface between the paranormal and covert *earthbound* operations. Evidence demands this.

Randy Koppang: It's quite possible to overlook and undervalue obscure details of CE4 research generally, although these certainly don't impair or discredit the major premise: actual human involvement in ET/CE4. Please comment on the re-abduction/kidnapping of CE4s.

Karla Turner: Yes! My first exposure to this was when my husband was kidnapped by "military" before I was ever into research. We were having our own experiences and trying to deal with them. In November 1988, my husband was taken to an underground facility (6); completely military, completely human. He had been in the military nine years prior (to our marriage).

This was very clearly, to him, a military installation and a massive storage installation. We thought (it may have been) the FEMA center in town, where we lived. Because it's the Continuity of Government FEMA facility, for one thing. And there are many generators/dynamos, all sorts of supplies. He saw this storage (type) area when being taken from the holding area. There were a number of other people in a very dazed, zombie-like state, as he was, taken by military guard down a corridor to a room where there was a Major, in uniform, behind a desk, where Casey was seated in front of the desk; questioned specifically about what alien activities our family had been involved in; what he knew about any of their agenda. He was so outraged at being taken, even in his dazed state, he absolutely refused. He even tried to sink back into the out-of-it state they aroused him out of for this so he would not have to answer. He was extremely outraged! The Major got more and more angry, and made threats to the family that we would be hurt if he didn't talk. He refused to talk.

Then — something — all we (know) is something was applied to the back of his neck and he went totally out. (Casey) doesn't know if he was interrogated in that state. I suppose there are states you can be put in where you're not aware but can still be talked to.

He was returned home the following morning. When he woke up, there was still some drug effect in his

system, and disorientation. He was still having the visual "trails" effect from whatever was given him. He recalled quite a bit consciously what had occurred. With two different regression sessions, a year apart, he was able to fill in a lot of what did go on, but never got past when they zapped the back of his neck.

I'd never heard of anybody being kidnapped by military at that point. Ever! This was an anomaly, and at that point was the most outrageous thing; I mean, far more outrageous, to us, than alien abduction had been, simply because of it being our own people.

RK: So you really do think there actually are aliens?

KT: I think there are non-human entities. I had encountered an insectoid being when I was five and a half years old. I don't know where they come from. It's as good a guess they're terrestrial in origin as that they are ET in origin. They're not like us! It bothers me that if they were ET, they are most adept at cover stories regarding where they are from. Also, in my opinion, we're a vital resource for them. They take from us something that's very necessary. If they came from some other system (etc.), why would we be a vital source for them if we're not part of their natural situation? So, I find it a little far-fetched to think that they came in from (outside). And if we ever get to the genetics (issue), I think the cross-breeding hypothesis is another cover story.

RK: In the chronology of your experience, was there a clearly defined event after which the human interference phenomenon began to occur, additional to what you believed were exclusively ET encounters?

KT: There were several events which made me aware of the human involvement angle. First off, consciously, I had recalled an abduction by an alien being when I was five and a half years old, always remembered from the time it occurred, throughout my life.(7) I had another event consciously recalled in 1981. Then, my husband began to recall events (occurring) in his childhood, clearly involving craft and entities. We (then) began having things happen in current time; in our house, CE4s. So we began to explore what was going on.

It wasn't until November 1988, when Casey was taken by the military, that we knew for sure how far military personnel would go. Up to this point, the minute he began to realize what was happening, and we (communicated with) someone in the UFO community by phone, we began having phone interference, mail tampering. The first two times we met with Ufologists, we were followed by the same car, two different times, two months apart. We began having helicopter overflights; numerous, numerous overflights, all times of the day and night, different types (of them). We lived in our house for five years and never had helicopters before then. It became the standard. I mean, I'd have nine a day!

So we knew there was a human element involved. First, we thought they were just monitoring (conversations). But once we made phone connections, we began having all this human-type activity: surveillance and a number of other things that are in the book.

RK: So that's what did it. You came out of the woodwork; you were on the phone — they said, ah! Here's one.

KT: Right! My son was in graduate school in physics. He was engaged to a woman in graduate school. She was an ROTC student. In her senior year (prior to graduate school), she had medical problems and wanted to leave the program, was in the process of going through the procedures to leave. But since it was coming-time for her to graduate, if she didn't get out, she'd have to ask for a duty assignment, etc., go through the rest of her training. Though she hadn't got out of the ROTC program at that point (she knew she was leaving), they said you still have time to sign up for a duty assignment. She went to the ROTC sergeant to make an assignment request. And she made a request that would keep her closest to her medical doctors, which happened to be meteorological duty. (When) she signed up, the female ROTC sergeant went ballistic! And she said, "You can't do this; you don't want to sign up for meteorology. Don't you want to get into the R&D program? That way, you'd find out the real truth about UFOs and aliens! You might even get to do research and test with it."

RK: You mean that statement was phrased to imply the sergeant already knew of your encounters?

KT: YEAH! The ROTC sergeant said this to my daughter-in-law (making) us think, hell, someone in the military really knows what's going on! (Since) we never told anyone outside of about six members of the family, and a few Ufologists — by phone.

She came home and told us, and was very, very frightened. She ran out of the office, not even answering the sergeant. She ran directly home and (demanded), "You know what this woman's done to me; how'd they know about this?" — really, really, upset. She did (leave) the program. So we knew there was human monitoring and surveillance of some sort, for all the things that were happening.

RK: I've heard variations of stories very similar. Yet, skeptics view hypnotically derived data regarding alien abductions as unacceptable. So if you counter that view by offering cases like this, where regression was unnecessary, or CE4 cases with total conscious recall of their experience, then the skeptical view shifts to a theory that some group perpetrates alien hoaxes, so as to create public belief in ET for some reason unknown, i.e., ETs actually don't exist.

KT: Well, you can believe what you want. But I don't know of any ROTC sergeant who's ever made a state-

ment like that to a person in the program. So I have no doubt of government involvement. We'd had evidence of it before Casey was ever kidnapped and interrogated. But the first time I ever knew anyone had been kidnapped and interrogated by military was my husband. And when I got into research and began to deal with numbers of other similar cases, then we start finding out this wasn't an anomaly. This is part of the program!

Melinda Leslie: (Was there something which started the human involvement...?) Well, I was on the phone from the beginning, talking to Bill Hamilton all the time, back in 1989. I was just having typical abduction stuff. But as far as military (contact), what may have made a difference was, I had already (visited) Area 51 with people a lot of times. So it's not necessarily my visiting bases, or the phone. Because all of that was happening (for quite some time).

The first time we had something military-related was (when) I was on a trip with two (others). We were going over Angeles Crest Highway to visit the infamous Northrop facility in Lancaster. There had been sightings out there. This was our first time to go out there, near Edwards Air Force Base. We were on our way... we had a trip that should have taken 1.5 hours that took three hours. We had real, classic missing time; a bunch of physical symptoms; confused and lost. So we pulled over and thought, wait a second... When we (determined) what time it was, we thought, that's impossible. We'd been on that road before.

During the next few days, I started to recall, consciously, an experience. And it was all ETs and an alien ship. The whole thing was with aliens. The three of us were together (etc.). Then I went to have regressions with Deborah Truncale, after I recalled it consciously. Apparently, I recalled seeing a guy in uniform standing in the back, on the ship, while ETs were doing something with us. There was a guy watching the whole procedure. I said this in regression. And managed to not only say this and discuss it with Deborah, but I had conveniently forgotten about this. And it was because of the recent experiences in July and November 1993, which jogged my memory to recall this one in 1991. One of my friends had said, don't you recall we saw a guy in uniform before — you talked about it, don't you remember? (The hypnoterapist confirmed this.) But I had conveniently put it out of my mind.

RK: The following question I wish you both to correlate. On page 115 (Taken), Beth recalls seeing "a uniformed, red-headed man," one of two who had led Beth to a facility in the American Southwest, seemingly in charge. In comparing synchronicities with fellow CE4s, do you find this (or very similar) red-headed man common in the encounters of others?

KT: Yes. A man of his description has turned up in more than one case (involving the military).

RK: Having a similar role, as opposed to just standing around and having red hair?

KT: Yeah. A couple of people have said the person interrogating them had the red hair.

ML: And that's the guy who may have interrogated me.

KT: And I will say, in my husband's case and in a number of other cases, the person who interrogated was an officer with silvery-gray hair, appearing to be in his fifties. So I've not just had this red-haired guy turn up in reports.

But what is ironic, if you want to talk about synchronicities, two summers ago, when I was working with "Amy" (from *Taken*). Amy was in Texas, I was in Arkansas. The hypnotist to do her regression work was in Oklahoma. So we met in Oklahoma at the regressionist's home. The regressionist told me when we arrived that she had a phone call from an old, old acquaintance, happening to be in town this particular weekend, insisting he wanted to visit her. She told him she really couldn't because she'd be working; we were coming over. (This man) was a Rear Admiral in the Navy.

RK: How did he know your regressionist?

KT: His family lived in the same area in Oklahoma. He'd grown up there, and they'd known each other years ago. He was now in Virginia, a medical officer, and according to him, one of the most highly placed medical persons in charge of the military hospitals.

RK: But over the years they'd lost contact?

KT: Yes. This was family stuff from years and years and years ago; hadn't seen him in quite a while. All of a sudden, this same

weekend, this man says he's in town, wants to (visit). And she said, wouldn't it be nice; tells me wouldn't it be wonderful if we convinced this Rear Admiral to take all this stuff seriously?

I said, Barbara, forget it, you can't do that. Either they already know, are not going to admit it; or they're out of the loop and aren't going to believe it. That's how it is with military. I said, No! I do not want him over here. After what we had happen with our military situations and other (CE4s), the last thing I want to do is have "friends" in military. I don't want that contact; don't like what we've had, didn't want any more! And she said, well, I told him not to come.

At 11: 30 at night he comes anyway! He's burly, reddish-blondish hair, thick body hair, reddish freckled, exactly like I had heard described in two other cases. And he barges in, basically told not to come. And we did question him, why he's in town, as he's based on the east coast in charge of medical facilities. His statement was first, both his parents were very, very ill, had been in hospital. So he'd come all the way home for that. Then, in the course of conversation, he let slip he'd been out skiing, barbecuing and partying, and doing all sorts of stuff; (no) mention of his family in hospital after that. So I found his story a little dubious.

He proceeded to take a great deal of time to tell me: "You can't go around talking about all this alien-abduction stuff until you have concrete proof, concrete evidence, and you can bring it out to show the public so they can see for themselves. You have no business talking about this. Nobody is going to believe you..."

RK: You mean he just dropped that into...

KT: Oh, yeah, immediately!

RK: ...into the conversation, just like the ROTC officer, he sprang "aliens" on you, outta nowhere?

KT: No, not outta nowhere. Because he knows what Barbara does. Barbara (Bartholic) does regression work.

RK: But was he there to immediately debate your ET encounters?

KT: No. He ostensibly came to see "old friends." We told him not to come. He spent a few minutes doing that, then got to the point of making this long exchange with me. And I said, I'm not here to convince the public of anything. The ETs are doin' that, one at a time, as they abduct people; people are knowing it's real. I don't have to go out and

tell 'em anything; it's happening and they're gonna know about it.

"Well, you can't do this. And you say this, expecting them to believe you and getting credibility..." I said, I don't care about credibility. I'm not out there to — my job's not to convince anyone. My job's to deal with people who already know it's real, because they're dealing with it. "Well, then," he says, "you talk about all these implants (8) and this sort of stuff. I've been in the military 25 years and never have I heard, officially or unofficially, (9) anyone in military discuss anything about UFOs.

First off, you know he's lying right there, okay? I said, In 25 years you never heard anything about it — "No, ma'am, never heard anybody say anything! And as for implants, I'm in charge of all the medical facilities. If any of our personnel had shown up having any implants, I would have known about it. And none of them do!" (10)

I said, Maybe you're not in "the loop," where they trust to give you information. And, boy, he didn't like that! Definitely. He said, "I've got high friends in the CIA and NSA. If there was anything going on, they'd've told me. And there's nothing going on, because they didn't tell me." And I said: SIR! IF YOU DID KNOW, hypothetically, there was ET activity of any sort going on, could you tell me? "Well, I couldn't do that, because it'd be classified information." Then why are you sittin' here telling me you know there's not any, when you and I both know if there was, you could not tell me anything?!

It was just strange, the coincidence of (him) being this red-headed (man) described exactly, with the thick body hair, as two descriptions of interrogators that people had reported.

RK: And, of course, Melinda has had a similar...

ML: Yes. A red-headed guy did my interrogation. But this (particular) guy is tall and thin.

KT: (Mine) was not thin. He looked like he did weights; real proud of it.

ML: Well, (my) person might do weights, but seemed to have a well-built, average build; strawberry blond hair and those blond-tipped eyelashes. He's looking at me real mean, with this real pretty eyes and eyelashes, you know, but he was convincingly mean. I had not read your book at that time. And in a phone conversation inviting you to come speak at MUFON, Orange County I brought up (this issue) James had spoken to you about, that you had seen this. And you said, Oh, yeah.

James hadn't told me the guy was interrogating! He just told me that people had seen a red-headed guy. That just blew me away, that it was a real similar description from other cases. When you have this happen, you don't

expect anything you get (will) ever match anyone else.

KT: Melinda, the first year, every time someone else (had) a validating report confirming or correlating what we've had — I swear, every time it was like someone doubled up a fist and hit me in the stomach. I would just get sick. It was one more thing which would not let me push this out of reality. I didn't want it to be real! I wanted it to be anything but real!

ML: The first person who (substantially) confirmed this happening to me was Licia. I would say: "Have you ever heard of this and this," and she would say, "Yes, when they did this to you, then did they do this to you," and I'd say, "How did you know that?"

KT: Of course, Licia and I (confirmed such comparisons) when we got together. Because she started to tell me something, and I finished it for her. And it was one of the most anomalous reports. What bothered her (was) I could finish the statement before she told me. Because I have a case in Arkansas of the same thing. But let's back off here and not be paranoid. There are many red-haired people, and in the military.

RK: I've tallied about 20 cases of this kidnapping situation. In your book you report others. How many do you know of?

KT: I never counted... it would take me a while to sit down and think of how many, as I'm also privy to Barbara Bartholic's research. She's had scores of cases in the last 15 years. And I know of quite a few amongst her cases.

RK: I'm not familiar with Ms. Bartholic.

KT: You won't be. She doesn't write or lecture. She's constantly working in this field, and said, you be my spokesman, I don't have time for this.

RK: You believe, however, that among the more prominent researchers of CE4, human involvement/interference is underreported.

KL: Yes, like Debbie Jordan/Kathy Davis, when Hopkins did the book on "Kathy Davis," he never mentioned that she had military/underground abduction with medical procedures. Debbie told me all about it. When I got ready to do this book, I said, Debbie, can I refer to your experience; as you're a well-known person, it (lends) credibility to these unknown people if they knew someone as well-investigated as you have been would say, yes, this happened to you. She said absolutely. Go ahead and do it. I'm writing my own book and will go into detail, so yes... And there are other of Bud's CE4s who've reported military involvement.

ML: Katharina Wilson's book mentions others.

KT: John Carpenter has had cases reporting military. David Jacobs — if he has had them — I'm assuming he has, but if he has, he would have said, 'you were just seeing ETs in disguise ... there are no humans involved

in this.' So this would not have been discussed.

ML: I spoke privately with Bud, where he narrowed it down to about five cases with (what he accepts as) military participation.

KT: But, Melinda, if there's only 5 cases, is

that, therefore, to say this isn't worth worrying about. These cases would be those you'd most want to pursue, if you're really looking for information!

ML: I said to him, isn't it potentially the most incredible and most fertile ground for research, because it's human, it's a traceable trail of events we can investigate by known procedures; as opposed to ETs, who use technology we can't follow, etc. He said, "Yes. But I (he) can only do so much. If you

want to (do it), I support you one hundred percent."

RK: You mean, by harping too hard on this aspect of CE4, the influential people whom prominent researchers attempt to gain association with, may react, further marginalizing the issue?

KT: See, I think that's a futile hope. All the researchers who try to gain mainstream respectability, therefore downplaying and backpedaling and partially censoring... (that's) a lost cause... you're never going to get the respect you want. I don't care what you do.

ML: Meanwhile, a lot of the evidence is being missed. People are being excluded from presentations...

KT: If you want credibility, get out of this field. You can't have both!

RK: (Licia has deduced the following may generally explain who is responsible for her re-abductions and surveillance, confirmed by someone she believed was a legitimate intelligence agent.) Those humans responsible for her monitoring (helicopter surveillance, phone taps, etc.) are not exclusively governmental/military ops. Rather, they represent corporate intelligence; e.g. Defence Intelligence Security Command, or PI-40. In addition to possible monitoring by a section of the National Reconnaissance Office, or an alleged DOD group called N9-11. Do you have any correlations in this area, so as to dispel imprecise conclusions based on blanket observations that humans dressed in paramilitary garb must be truly military?

KT: I don't have any names of specific groups, intelligence, military, civilian/corporate. No. From the cases we've (pursued), here's what I can say: The facilities include personnel from more than one branch. The facilities themselves are obviously government authorized and funded, because they match those we've known are government underground facilities.

RK: The branches were distinguishable?

KT: Yes. By uniform, at least. "In 'Angie's' case" (11), the people told her she was (they told her several things) part of a genetics/cloning experiment (this was from the humans who had her). Another time, the military people told her she was part of an ongoing military mind control project called "High Shelf Project." And we didn't know if that was the name of a project or if it was a term like very, very high classification of secrecy, or covert. We didn't know what that meant.

ML: When you (named) that during your lecture, a (personally well-known) investigator said that "High Shelf" was an actual name of an MKULTRA subproject.

KT: Okay, which "they" told her. And Angie would know nothing of this, absolutely nothing of this! She said they told her they were part of the "High Shelf" operation, an ongoing mind control program. And that their special group, comprised of people from all branches of military, operated primarily in underground bases. And I wish your friend would speak to me. We've never had anyone identify what "High Shelf" means.

RK: MKULTRA has been documented as a bonafide CIA covert program.

KT: Why would they be picking on somebody like Angie, who's

a remote wife of a rancher in the middle of nowhere in Tennessee, but who's had CE4s since childhood?

RK: ...that she came up with that term.

KT: They told her the term. And she would have no way of knowing that.

RK: This is an anomalous thing, that they come up with such details and don't need hypnosis to recall such descriptions.

ML: In my particular two incidences, I can say I'm 99.99% sure it's military, just because of their uniforms, their actions, and treatment of me. It just smacked of military.

KT: And it's authorized at some level. They've got money out the kazoo, the best equipment...

ML: It could be both (military and corporate). And I don't think we need to say it's one or the other, or both doing it separately. It could be that at this level there isn't a distinction between the two.

KT: It makes use of all those resources as it wants to. Because it's above them. And can pick what it wants! I'll tell you something, though. Civilians are involved, obviously. Because there are medical and scientific personnel. A woman who was working at a university hospital, a big one in Arkansas, was wanting to move, get a better job. She was in the office computer end of things, not the medical end.

She got an offer; apparently a real smart woman and good at her job. She got a phone call, having gone to a "head hunter" for different job possibilities in (various) areas; got a call back for an interview with an astounding salary base. But she had to fly to Dallas to be interviewed, and they paid for her flight to Dallas. She met at a restaurant with representatives of this company. And they told her almost nothing; very, very little about the details of the work. (I think it frightened her quite a bit after she thought about it.) But it was great pay. They said they would pay for her to relocate.

The one question they asked that made it stop for her was: The job, by the way, was underground. You would have to be underground for two years. You could not

come up for two years — not that you'd work underground, then go home on the surface. You'd have to stay underground and live and work for two years if you want the job — pays a lot of money, gives you a lot of benefits. But you stay underground.

RK: This woman told you her story directly?

KT: Directly. And she did not take the job. No. She said no way in hell could she stay underground for two years.

RK: Did she tell you the name of the company?

KT: No. She said after (leaving) the interview, she started thinking about how weird it was regarding whatever, apparently, was said; there were no threats made, everybody was very nice to her. Yet, the way they shut off and shut down; things that were implied made her very, very uncomfortable. And she has left the state. I don't know where she's gone. This was two years ago (1993).

RK: She was just a woman with an expertise they wished to recruit.

KT: Yeah. She was a computer operator/clerical type, good with computers; it would have been a desk job.

RK: How did you run into her?

KT: She worked with a friend who (went) to our CE4 discussion group. They worked in the same university hospital office together; was a good friend of hers. That's how (the friend said) when she heard about it, she said, "You gotta hear this!"

ML: You know (Eisenhower's statement) "Beware of the Military/Industrial Complex"? That's what it is. At this high level, the military/industrial complex is one and the same. Military/industrial is the same thing, when you get to that level.

KT: Right!

RK: Where does one leave off and the other begin? That may be the prerequisite for understanding this issue.

The Reptoid Invasion

Just in time for the Chinese astrological Year of the Dragon, reptilian aliens have successfully completed their invasion of conspiracy literature. From the "Dulce Wars" to David Icke, the reptoids have seized our imagination. What's it all about? A brief overview of the reptilian mythos follows.

In the realm of conspiracy, nothing since the airing of the "Alien Autopsy" footage has stirred up the amount of contention as the phenomenon of David Icke, with the release of his book, *The Biggest Secret* and the launching of his inflammatory website in April of 1999. With a shrillness that is unmatched, David Icke claims that the world's most prominent geopolitical players and the governments and multinational industries that they operate are all fronts for interdimensional reptilian puppetmasters. These controlling reptilians are described as semi-physical inhabitants of "4th density," a plane of reality that is at a higher vibratory rate than the material 3D world.

The reptilians' domination-oriented consciousness is said to resonate and express itself in the physical realm of our 3rd density reality. How? Via the institutions, the ideologies and the DNA of the reptilian hybrid custodial caste that comprises the world's royal and elite bloodlines. To document his case, Icke has meticulously and convincingly traced the steps of these elites and their establishments over the millennia.

Despite the audacity—and the weirdness—of his claims, the sheer mass of historical data Icke has accumulated to substantiate them is impressive. Whatever credibility this feat has earned him, however, is completely ruined by his ongoing fervent and surrealistic denunciations of public figures. For example, Icke claims that Queen Elizabeth and the Queen Mum are, in reality, "shapeshifting reptoids," intent on the satanic ritualistic eating of babies and the drinking of freshly-sacrificed human blood.

While it is amusing to picture these comically lurid tableaux—and it is quite fun to pretend for a moment that such stories are "true" (two thumbs up for entertainment value!), he has baited himself for derision with these ridiculous, wildly defamatory remarks. Icke's sensationalistic slant has discredited the genuine value of some of his information.

It is a disservice to serious scholarship that has been done on the subject matter by others and himself.

Icke's most cherished refrain, "shapeshifting reptilian," is also his most misleading. All human beings share some DNA structures with reptilians, in fact, all biological Earthlings share a lot of the same genetic codes. It is said that we humans share up to 80% of our genetics with spiders! Furthermore, human beings possess a "reptilian brain," located at the very core of our noodle. Indeed, the "intelligent" gray matter of the outer neocortex appears to be abruptly grafted on top of this reptilian core.

Icke has an excellent article currently posted on his website about the characteristics of this inner reptilian brain and the functions and attributes of the reptilian level of consciousness that exists within all humans. It is not surprising to learn that these human reptilian brain characteristics of territoriality, domination and addiction are what typify the qualities of our supposed 4th density reptoid overlords, something Icke duly points out.

The existence of the reptilian brain and the limbic system within every human being are the first clue that the reptoid phenomenon is more complex and multifaceted than Icke's overly-literal shapeshifting accusations would indicate. Dragons appear extensively in worldwide mythology. If only one could ask England's patron saint, George, so enshrined for slaying dragons: "Exactly what animal were you killing?"

Was the dragon symbolic, literal or both? Besides our shared DNA codes with reptilians and our reptilian brain stem, there is also an archetypal reptilian resonance, which echoes from the mists of time and legend, perhaps the legacy of the dinosaurs. This does not make any person a "shapeshifting reptilian," per se. A human being may have a resonance with reptilian energy or even direct resonance with evil extraterrestrial 4th density reptilians. A psychic adept may be able to perceive such reptilian energetics overlaying the field of a human being, or to perceive other-dimensional reptilian aspects of that person's soul—but that is still *not* the same thing as a human person being a "shapeshifting reptilian"!

While there are numerous strange accounts of the 4th density reptoids' ability to project holograms that make them appear as physical humans for limited amounts of time, it is highly doubtful that this is what is occurring with the Queen Mum. Even by most far-out eyewitness testimonies, no reptoid could sustain the ruse of appearing human for twenty-four hours a day, seven days a week. It is far more likely that the Queen Mum is a human host for a nonphysical reptilian entity, though I am not aware of evidence of that. Icke's miscommunication comes from his overly literal 3D read of 4th density phenomena. This is done either out of a genuine, if misguided, sense of urgency on his part or it is his conspiracy huckster's catchy sales pitch. Could his tack render him the next Chicken Little or Boy Who Cried Wolf...?

Fourth density has been variously described as the astral plane, dream-time or the imaginal realm, among other terms. It is an order of reality that interacts with the physical plane.

There is an archetypal or mythic quality to it, as opposed to the familiar "hardness" of 3D reality. This does not minimize the "reality" of 4th density or its denizens at all. Dreams, ideas and beliefs are quite literally what shape and inform the material world. Without the immaterial phenomena of dreams, ideas and beliefs, no bridges would be built, no wars would be fought, nothing would be bought, etc.

Theoretical physicists are currently working out the long division that would mathematically explicate the hyperdimensions that interpenetrate

the physical world. However, the more right-brained members of our species and countless native cultures have forever recognized these other realms.

The point I'm making is that there is some truth to what David Icke is espousing, even to some of his more insane allegations. I just think the

way he chooses to discuss the information is misleading and self-defeating, or maybe I'm not getting the joke. Perhaps the tenor of his shrieking outrageousness is actually to provoke rebuttals and to spark lively commentary—even if much of it is derogatory of him. In that case, he is a master of the maxim that there is no such thing as bad publicity! He has certainly succeeded in getting people to talk about him AND the reptilians.

To be fair, Icke's avocation is not easy. Fourth density phenomena do not translate neatly into 3rd density



language and proving their "truth" is a challenge, at best. I know, because I am also wrestling with the process of enunciating about such interdimensional issues as reptoids, while attempting to avoid the snickering wrath that has been visited upon him and others before me. I am completing a book that involves Phil Schneider, who lectured around the US about his 17-year stint as a govern-

ment geologist in secret underground bases. Schneider was found strangled to death in his apartment within two years of going public. His more remarkable claims related to his personal involvement with back-engineered alien technologies and his physical skirmishes with tall, reptilian "big nosed Greys." (Hardcore conspiracy nuts may recall tell of the "Dulce Wars" and his participation in same).

Regardless of anyone's opinion of Schneider's credibility, the fact is that the legal investigation of his death was grossly mishandled. The evidence overwhelmingly indicates that he was murdered and that the murder was covered up. In my book's early stages, my editor and publisher, Peter Moon, advised me to remove all references to "reptilians" or "big nosed Greys." He thought these just served to discredit Schneider in the eyes of the average reader and to minimize the facts of Schneider's murder and its cover up. I understood Peter's point, but I also felt that to avoid discussing these issues would be to miss a crucial element of Schneider's message—and of his untimely death. It would be like pretending that there wasn't this slaughtered rhinoceros on your living room floor. Plus, there would not be much else left to write about after ascertaining that a series of local law enforcement personnel had suspiciously botched their jobs.

If I could not mention Schneider's harrowing tales of hand-to-hand combat with aliens, then there simply wasn't that much left for me to say about him. These claims are what got him on the lecture circuit to begin with and are likely related to what got him killed. I was deeply aware, however, that to take some of Schneider's claims seriously would have the effect of transferring a certain lack of credibility to me.

The main argument used to dismiss certain claims of Phil Schneider, Preston Nichols, Stewart Swerdlow or any percipient of the extraordinary is that these claimants are insane, therefore nothing they say is valid. This is a unilateral and lazy way to avoid dealing with the unsettling implications of their information. That the hegemony would label such folks as "insane" is a bit of the pot calling the kettle black, in my opinion. The predominating orthodox scientific ideology about human existence, of which Darwinism and the Many Worlds Interpretation of Quantum Mechanics are prime examples, is that "reality" is some kind of an arbitrary accident that replicates itself and

echoes ad infinitum, for no good reason at all. This is sanctioned insanity and it is the state religion of America!

Don't get me wrong. I happen to agree with aspects of the Many Worlds Interpretation. Yes, the gods must be crazy! What I love best about this postulate is that it actually validates the reality of the Queen Mum's being a cannibalistic practitioner of satanism! It validates every crazy thing ever asserted by Phil Schneider, David Icke, every alien abductee and Montauk Project survivor. Because on a quantum level, every possibility is true! For example, the Many Worlds Interpretation of Quantum Mechanics would allow for the existence of parallel timelines where the Earth's dinosaurs never became extinct and instead, continued evolving. Could it be these reptilian realities that are reported to be impinging on our own?

There is a certain Orwellian condition, whereby some realities are more "true" than others. This has yet to be factored into the MWI theory, as far as I am aware. The "truth" or pervasiveness of any given reality corresponds to the amount of consciousness energy associated with it. The import and the power of mass consciousness energy cannot be overlooked. This is the factor that makes advertising, public relations, "positioning," "perception" and mind control so important to people with huge profits to be made by paying for these services. The more consciousness energy entrained into a concept, the more "real" or "true" it appears. Thought and belief generate reality. It is that simple.

In any case, Icke is by no means an innovator in the field of reptiliana. My own first encounter with "reptoids" was in 1991, in a far-out channeled newsletter I then subscribed to called the Revelations of Awareness. The vivid descriptions of planetoids hauling millions of invading reptoids Earthward at the speed of gravity (18 times faster than the speed of light, we were informed) completely gripped my imagination. This same mythos made headlines in 1997, with the advent of the Hale-Bopp comet and in the liturgy that resulted in the mass suicide of the Heaven's Gate cult.

There is a basic incongruity within the reptoid mythos, as promoted by the Cosmic Awareness, Icke and others, which short-circuits logic. Why are these flotillas of space rocks bearing giant, man-eating lizards "coming to get us," when it is also said that the "Lizzies" were always here, genetically-engineering the human race from day one? It is also said that the reptilians have been constantly tweaking human history towards their nefarious ends, using their evil time travel tricks. How are they supposed to have full mastery of our time and reality—yet they are schlepping their way over toward us, en masse, still yet to "arrive"? Maybe, as author, Stewart Swerdlow (*Montauk: The Alien Connection*) suggests, it is a matter of human beings awakening to their presence that has made them appear, in an archetypal sense, to be "arriving" to the growing body of those who perceive them.

The Cosmic Awareness, as channeled by Paul Shockley, was the early-nineties forerunner to David Icke's website, as a reptoid information clearing house. The awkwardly-phrased, channeled statements of the Awareness betrayed zero emotional affect, an interesting counterpoint to the banshee stylings of Icke and other upstart conspiracy rantmeisters of late. This is true despite the fact

that many of the Awareness' readings were far more outlandish than Icke's claims, though they were free from his obsession with satanism.

Awareness would "indicate" that many of the political leaders of our world had been "switched" with cloned "robotoids" that were piloted by interdimensional reptilians, etc. Again, fun weird stuff to contemplate, seeing as it was much more interesting and actually seemed to make more sense than ABC World News Tonight, et al., especially during that bogus, state-sponsored weapons infomercial that passed for coverage of the Gulf War!

Spurred on by the reptoid specter raised by Cosmic Awareness, I bought two books by the self-described ex-government cryptographer and Sumerian scholar, R.A. Boulay, *Flying Serpents and Dragons and Dragon Power* (published in 1990 and 1992, respectively). He adds his own insights to the Sitchin information and basically says that the Anunnaki were a custodial crossbreed of reptoid/primate/hominids. The Anunnaki were a "royal" half-caste that were engineered to lord over the slave caste that had been created to mine gold for the aliens and to do other menial tasks. (It would be interesting to find out who that guy really is and his motives for writing those books. I do not think that Boulay is his real name).

Boulay's story dovetails quite nicely with the Merovingian myth about the origins of their bloodline, as outlined in the cult classic, *Holy Blood, Holy Grail*, by Baigent, Lincoln and Leigh. The ancient Merovingian legend goes that the queen was already pregnant by the king and went for a swim in the ocean, whereupon, she was raped by a "Quinotaur." The resulting hybrid offspring, Merovee, became the founder of the Merovingian bloodline, into which all the royal houses of Europe have since striven to marry, as detailed ad nauseum by Baigent-Lincoln-Leigh and by Laurence Gardner in his *Bloodline of the Holy Grail*. The present generations of their offspring are the self-same folks implicated by Icke & Co. to be the fearsome reptoid half-breeds that are selling the rest of humanity out to the "microchipped" New World Order.

The Quinotaur figure is somewhat reminiscent of the Oannes character of Sumerian lore, who would emerge from the sea and teach agriculture, literacy and architecture to the primitive locals. This amphibian figure is also similar to the West African Dogon tribe's tales of 'fish-men' from the stars. There is the European children's fairy tale of the Frog Prince and also the abiding obsession with dragons of the Chinese. "Japanese legends of serpent/dragon and human marriages, seductions, and liaisons abound," says Wm. Michael Mott, in another excellent, extensively researched article currently posted on David Icke's website.

If you look at the legends of the origins of some Scottish clan names, you'll see a similar story. For example, the name MacLaclan is said to derive from "Lakeland," the underwater kingdom, a la Atlantis. The daughter of the king of Lakeland, who was described as a "dark," large, non-human sea creature was said to have married an ancient warlord and thus founded the new dynasty. The names MacVeigh, along with its cognates, such as MacFie, MacPhee and Duffy also have this legend. This underwater princess bride would seem to bear a not insignificant resemblance to "Nessie," the Loch Ness Monster! These are the clans' own legendary accounts, not a David Icke smear.

Given my deeply-embedded fascination with all these related subjects, I was not surprised to discover that, according to Icke, I myself come from a bigtime "shapeshifting reptilian" bloodline. Furthermore, there

are numerous references to my celebrated clan mate, Robert the Bruce, as being the founder of modern Freemasonry. The Masons are the subject of endless calumny, implicated in nonstop satanic wrongdoing by Icke and other conspiratologists.

The good news is that I don't eat babies. Not the human ones. I love organic baby salad greens, even if a bag sells for the weekly wage of the person who picked them. It's not my fault that the CIA's ongoing destabilization of the "developing world" has resulted in this state of affairs! If anything, I am doing the opposite of selling humanity out into a microchip-implanted existence! (Perhaps I am of the brontosaurus line?)

The upshot of my investigation into all of this human/reptilian weirdness is that I have trained myself not to believe or to judge anything anymore, including all the "common sense" we take for granted. I do my best to "hang out" with information, while endeavoring to discern its ideology and its agenda.

I believe that the contemplation of all this bizarre reptilian information is worthwhile, in the sense that it can aid 3D-bound consciousness in a better understanding of multidimensionality. My assessment of David Icke's reptilian witch hunt is that it's just more of the same divisive, disinformational bullshit that he accuses the reptilians and their half-caste "toadies" of perpetrating on the rest of the human species. However, to whatever extent that his website and literature can increase an awareness of and warn his audience about the evil reptoid within us all, I think the work he is doing is invaluable. If nothing else, it is excellent entertainment.

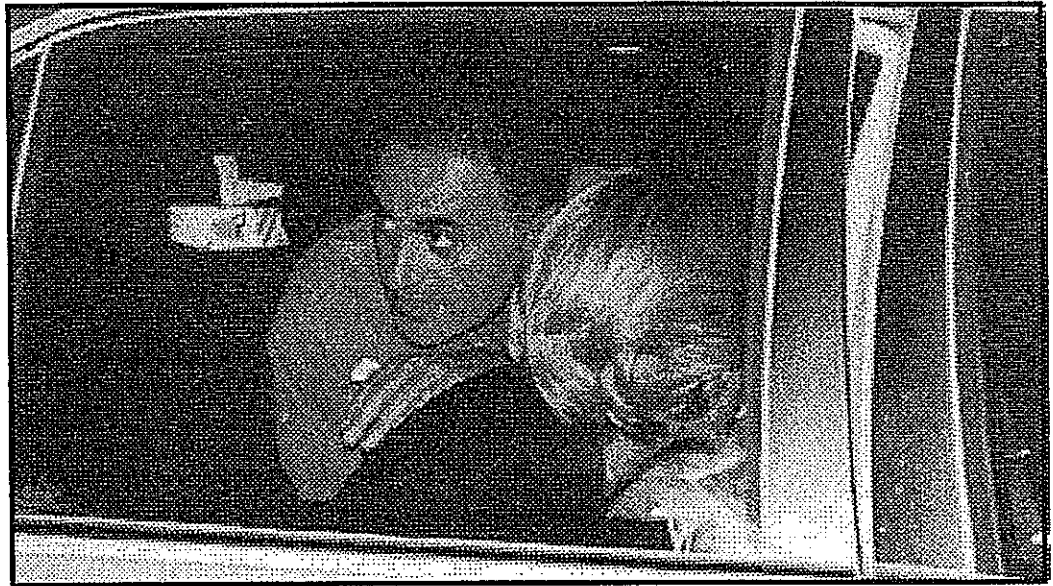
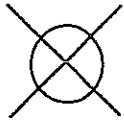

Reliable sources from the super market tabloids have confirmed our earlier breaking story that Di has her eyes set on being the First Lady of America ... According to these sources, the Princess of Wales has come to the United States in search of an American husband who will help her forget the pain and suffering she endured while living in the royal palaces and partaking of her fairytale life.

Wives and girlfriends beware. It is rumored that sources close to the top of the invisible world government have concluded that Princess Di has the charisma and power to squelch all ugliness that would be involved in your divorce, accidental death or unfortunate



suicide. If you have an inkling that your man may be the intended new husband of the Princess, it would behoove you to divorce and quickly disappear. Unless you want to end up on a mountainside like Ron Brown.

Within 24 hours of the release of the *Rumor Mill News*' story on Diana, the *San Francisco Chronicle* ran a story in its gossip column titled, "Di Charms Windy City - Di in Chi-town."

The article went on to describe Diana's visit to Chicago. It also gave the names of two of the three men she had danced with. Phil Donahue and Roger Wilkie were named, but the anonymous third fellow was never named. Who could the anonymous dance partner have been? Bill Clinton? Jay Rockefeller? George W. Bush? Maybe it was a playboy from Hollywood named Emad Fayed. Or could the anonymous suitor have been the handsome publisher of *George* magazine, the Prince of America, John F. Kennedy, Jr.?

In the June issue of *Rumor Mill News* we presented an in-depth analysis of the breakup of the marriage of Prince Charles and Princess Diana. In the series of articles, we also presented information showing the connection between the royal family and the international bankers. We discussed the feud between the Rothschilds and the Rockefellers, and we explored the connection between the Rockefeller family and President Bill Clinton. We can summarize by saying that international bankers are trying to merge the U.K. and the U.S. as the first step in creating a New World Order with One Government ruling everything. To accomplish this, they wanted to use Princess Diana and her children; both the born and unborn.

Diana's "handlers" had decided that her popularity would have brought back the "mythic" Camelot days of the Kennedy years. A Royal Princess in the White House would have been the first step to turning the Presidency into a royal throne perpetuated through bloodline rather than ballot box. By the time William would become King

of England, one of Diana's newly born American children would become an elected official, and well on his or her way to becoming President of the United States.

In the same issue, *Rumor Mill News* presented the short list of American men that the New World Order had chosen for Diana. Diana would be allowed to choose her new husband from three men that had been handpicked for her. Each man represented a powerful New World Order family: Jay Rockefeller and George W. Bush represented their families respectively. The other candidate was Bill Clinton. All three men were married. Whoever the lucky man was, his wife would have been as unfortunate as her husband was lucky.

Rumors have circulated in Arkansas since the time Bill Clinton's mother was born that she was the illegitimate daughter of Winthrop Rockefeller. This would explain how a back-water hillbilly from Hope, Arkansas ended up as a Rhodes Scholar, Governor of Arkansas and finally President of the United States. However, Clinton was angry with the Rockefellers because they had chosen to marry a *legitimate* Rockefeller to Diana. He turned his back on his own blood family, and defected to the enemy camp - the Rothschilds.

Diana had a mind and a heart of her own. The short list of husbands was not agreeable to her. Her first choice for a husband was John F. Kennedy, Jr.

On July 20, 1996, *Rumor Mill News* received an update from a source in Chicago. We were told that Diana's visit to the windy city was actually a clandestine meeting with Rothschild bankers. It appeared that the Rothschilds had bought the hand of the princess and

would marry her to a man of their choice. Now it became clear why President Clinton had defected and joined the Rothschilds. Would Diana have been happy with Bill Clinton, or was Diana pressuring the Rothschilds to choose John Kennedy, Jr.?

On Tuesday, September 24, 1996, President Clinton was in New York signing the Comprehensive Nuclear Test Ban Treaty. This meeting had been planned for months, and the President could not get out of it. Knowing this, Hillary made sure that Princess Diana was invited to the White House on that day. The White House meeting between Hillary and Diana was only two days after the sudden, swift and secret marriage of John F. Kennedy, Jr. to Caroline Bessette. Could Hillary have been afraid that now that JFK, Jr. was no longer available, Diana would settle for Bill?

At the White House breakfast, Hillary told Diana something that made her leave the United States immediately. What could Hillary have told Diana that would have made her turn and run? Maybe Hillary talked about Juanita Broderick, the woman who says Bill Clinton raped her. Maybe Hillary told her how Bill had killed Hillary's lover, Vince Foster. Diana understood this type of control. She believed Charles had ordered her bodyguard and best friend killed. Whatever Hillary said to Diana at that September White House

meeting, Diana left the United States and never returned.

Not only did she never return to the United States, she immediately began a relationship with the son of a powerful man whose disdain for the Royal Family matched her own. An MI-6 document shows that Diana began a relationship with Dodi Al Fayed in November of 1996, just days after the White House meeting with Hillary. Did Diana believe the Al Fayed family was powerful enough to protect

her from whatever it was that Hillary had told her?

The MI-6 document is one of several found by Vienna police when, acting on a tip from Mohammed Al Fayed, they arrested long-time CIA operative Oswald LeWinter. LeWinter was charged with trying to extort money from Mohammed Al Fayed for phony documents. Off the record, LeWinter claims the documents are real. He said, "I had a choice at my arrest to identify the documents as genuine or as fakes. If I said genuine I would face charges in the U.S. of high treason... so I said they were forgeries and was arrested for Fraud."

Even though there were many secret documents in the hotel room where LeWinter was arrested, only one was released to the Vienna newspaper, *The Kurier*. The MI-6 document reads: "1. Relationship initiated between Diana POW and Dodi af according to reliable intel sources in November 1996. Intimacy begins shortly after they meet. (Report filed)."

The New World Order and its Opposition

A series of *Rumor Mill News* articles also covered the origins of the New World Order. We released information that was not widely known about a group of men who opposed the New World Order. This covert group, known only as Faction 2, was/is centered within a group of Austrian and Bavarian royal family members. These men all claim direct descent from one or both of two groups: the original Knights Templars and the Canaris Conspirators.

Admiral Wilhelm Canaris headed the German Abwehr (military intelligence) during WWII. The conspirators who planned the assassination of Adolf Hitler were hidden and/or protected by the Abwehr. After the Hitler assassination attempt failed most of the conspirators were killed. The ones who were not captured made their way to the United States. Others, whose identities were not compromised, such as Kurt Waldheim, stayed in Europe. After the war, some of these men and their children were forced

by the U.S. government to work for them, or be turned over to the Israelis to be tried and hung.

The members of the Abwehr who ended up in the United States quickly began to seek out Americans they could trust. One of these Americans was an OSS (Office of Strategic Services – the forerunner to the CIA) man named William Casey. The top men in the OSS came from the East Coast elite establishment. Most were connected with the powerful international banking families who had created the Federal Reserve Banking System. William Casey was a poor Irish Catholic from New York City. Even though he was smarter and more qualified than the rest, he did not have the right pedigree. This was made clear to him, and to many other “poor” boys who tried to be spies. William Casey continued his ties to government intelligence agencies until he became CIA Director under President Reagan.

During Reagan’s Administration a scandal known as Iran/Contra dominated the headlines. One of the top names in the scandal was Adnan Khashoggi. At the time, Khashoggi, an arms dealer, was considered the richest man in the world. His brother-in-law and partner was Mohammed Al Fayed, Dodi’s father.

The connection between Al Fayed and the Iran/Contra scandal was difficult to prove, but Richard Taus, former FBI agent, states that Al Fayed and Khashoggi were connected to the Iran/Contra scandal through Castle Securities. Castle Securities was formerly Drexel Company, which was connected to Drexel, Burnham, Lambert and the junk bonds scandal. Taus states that many people who were involved in Castle Securities were part of a group out of Freeport, Long Island known as the K-Team. Most if not all K-Team members were part of the Iran/Contra scandal. The K-Team had a front operation with a patriotic sounding name: the National Freedom Institute. The K-Team called its operations, “The Enterprise.” (*Defrauding America*, Rodney Stich, pp. 668-674)

Taus reported that the K-Team was a CIA operation which included many infamous names such as Oliver North, Admiral John Poindexter, Richard Secord, and Adnan Khashoggi. Taus and Stich both state the K-Team was filled with assassins.

At the beginning of the Iran/Contra scandal, Dodi Al Fayed was 24 years old. Many believe that Dodi acted in the capacity of a money launderer by investing the proceeds of his uncle’s illegal arms deals in Hollywood films. During that time, Dodi produced two major hits: “Chariots of Fire” and “The World According to Garp.”

Another interesting aspect to the Iran/Contra scandal happened when Oliver North suggested that his group, i.e. the K-Team, tap U.S. allies for assistance. As Director of Central Intelligence, Casey endorsed the

idea and informed Robert “Bud” McFarlane, the National Security Advisor to President Reagan, to seek assistance from South Africa as well as Israel. In 1984, Casey dispatched CIA officer Duane R. “Dewey” Claridge to South Africa to ask for assistance. (*Guts and Glory*, Oliver North, p. 193) Princess Diana’s father, Lord Earl Spencer, had business ventures in South Africa. His son, Charles Spencer, was a permanent resident of South Africa.

Lord Earl Spencer was the best friend of Adnan Khashoggi’s brother-in-law, Mohammed Al Fayed. Al Fayed was connected to the K-Team and their “Enterprises” through Castle Securities. The ten year friendship between Lord Spencer and Al Fayed eventually led to the introduction of Al Fayed’s 40 year old son, Emad “Dodi” Al Fayed, to Princess Diana. Mohammed Al Fayed and Adnan Khashoggi had been connected to the K-Team through their business deals. The K-Team was/is made up of CIA operatives who were/are members of Faction 1 – the New World Order, and Faction 2 – the opposition to the NWO. Al Fayed and Khashoggi were connected to the men who make up Faction 2.

Khashoggi, Al Fayed and many other members of Faction 2 are Muslims. Since Israel is allied with the New World Order, the *enemies* of Israel are natural allies of Faction 2. In reference to the MI-6 document, Mohammed Al Fayed has been quoted as saying, “I intend to establish the truth behind the tragic events in Paris last August. MI-6 Director David Spedding is named in one telex and a squad from the Israeli secret service Mossad, referred to as the “K-Team,” appears in another.” Al Fayed has to know that the K-Team referred to in the MI-6 document was not Israeli. Why did he place the blame on the Israelis? Did he hope to gain help from former allies in the old K-Team? The MI-6 document seized by Vienna police and published in the *London Mirror* reads in full as follows:

seriously disturbed by liaison. PM considers any al Fayed relationship politically disastrous. Edinburgh (Prince Phillip -ed) sees serious threat to dynasty should relationship endure. Quote reported: "Such an affair is racially and morally repugnant and no son of a bedouin camel trader is fit for the mother of a future king," Edinburgh. (Report filed) 3. Request from highest circles to DEA attache UK for 6 on Dodi re: Cocaine. See File forwarded to UK embassy DC. (Copy filed) 4. US liaison to MI6 requested by David Spedding for assistance in providing permanent solution to Dodi problem. Blessing of Palace secured (Twiz filed) 5. WHuse (White House -ed) denies Spedding (head of MI-6 - ed) request. Harrison authorized only to arrange meeting for MI-6 representative with K-Team Geneva. (Twiz on file) 6. Meeting in Geneva reportedly successful (Report filed) 7. al Fayed Mercedes Limo stolen and returned with electronics missing. Reliable intel source confirms K-team involved. Source reports car rebuilt to respond to external radio controls. (Report filed).

When Al Fayed saw this document, which Oswald LeWinter tried to sell him, he had to have known that the CIA was involved in the death of his son Dodi and Princess Diana. Al Fayed was connected to the CIA K-Team that was mentioned in the MI-6 document. Number 5 on the MI-6 document states that the White House, meaning President Clinton, denied Spedding's request. What had David Spedding requested? Number 4 from the MI-6 document tells us: "4. US liaison to MI-6 requested by David Spedding for assistance in providing permanent solution to Dodi problem. Blessing of Palace secured. (Twiz filed)."

David Spedding, head of MI-6, was requesting assistance from the United States in finding a *permanent solution* to the Dodi problem. The term "permanent solution" is a common Intelligence Community euphemism for murder. Even though the White House did not approve Spedding's request for a US liaison to MI-6 for the purpose of murdering Dodi, the White House did arrange a successful meeting with K-Team members in Geneva.

Evidently, the Geneva K-Team members acted as independent contractors and picked up the "contract" on Dodi. It is a common practice for CIA agents to act as "independent contractors" so they can not be traced back to the CIA and to the United States. According to the MI-6 document, the K-Team stole one of Al Fayed's limos and began to make plans for Dodi's murder. The Limo was fitted with electronics that allowed it to be remote controlled.

Diana fled from her White House meeting with Hillary and went directly to Mohammed Al Fayed.

Had Diana's father told her to seek out Mohammed Al Fayed if she ever needed help or protection? If Lord Spencer was involved in business with Al Fayed and the K-Team, then Spencer would believe that Al Fayed had the means of protecting Diana. Even Lord Spencer's widow went to work for Al Fayed at Harrod's Department Store.

Al Fayed saw the benefits of a union between Princess Diana and his son Dodi. Had Diana married Dodi, she would have learned everything about the NWO from a group of men who were the age-old enemies of the NWO and the British Throne. Diana would have become the #1 enemy of her former in-laws. Both the NWO and the Palace were afraid that Diana could expose them to the world. When the NWO discovered Diana had sought out the Al Fayed's for protection and was planning to marry Dodi, they knew they had to do something so evil and so monstrous that Diana would fall in line and never again try to defy them. At this point, they still needed her to unite Britain and the U.S. as the first step to a One World Government.

The men who planned the assassination of Dodi knew Diana was pregnant and would be marrying Dodi as soon as possible. They needed to act fast, before Diana and Dodi were married and living in the Paris Windsor Palace owned by Al Fayed. According to renegade MI-6 agent Richard Tomlinson:

Ritz security boss Henri Paul, who drove the death car, was an MI-6 informer paid to spy on Diana and Dodi. The Diana crash was chillingly similar to a previous MI-6 plot. That plot was to assassinate the Serbian leader Slobodan Milosevic in Geneva using a powerful laser strobe light—similar to that described by witnesses to the Paris crash—to blind the driver.

Richard Tomlinson lived in Geneva. The assassination plan that Tomlinson claims was "appropriated" to use on Dodi had been created in Geneva. The K-Team that was enlisted by MI-6 was also in Geneva. Tomlinson further states:

I was shown a document proposing an assassination of President Milosevic of Serbia. The plan was to use a strobe light to blind his driver as he went into a road tunnel in Geneva. When I heard witnesses in Paris talk about a bright flash before Diana's car crash, it made sense. A tunnel is a perfect place for an assassination, with fewer witnesses. The Paris tunnel is also ideal because there are no crash rails along the central pillars, so it's a death trap.

Tomlinson says his claims about MI-6 involvement in Diana's death will shock the world. This sounds uncannily similar to the statement made by CIA operative Oswald LeWinter that, "The true facts about the murder of Diana would shake the World to its foundations, since

it involves a number of governments and more than a number of intelligence services.”

The Mercedes that Diana and Dodi were using on the night of August 30, 1997 had been stolen five months earlier, on April 20th. This meant that the accident had been planned for at least five months. But who had planned it? As Diana told her therapist: “One day I’m going to go up in a helicopter, and it’ll just blow up. MI5 will do away with me.” (*Diana On The Edge*, Chris Hutchins & Dominic Midgely) Diana knew that the Palace thought she was a “loose cannon,” and she was certain they were not beyond murdering her.

The MI-6 document shows that Prime Minister Tony Blair, the Palace and Prince Phillip – the Duke of Edinburgh – were seriously concerned about the relationship between Diana and Dodi. They believed it was politically disastrous and could threaten the dynasty. As this document states:

2. Reliable source reports Palace seriously disturbed by liaison. PM considers any al Fayed relationship politically disastrous. Edinburgh sees serious threat to dynasty should relationship endure. Quote reported: “Such an affair is racially and morally repugnant and no son of a bedouin camel trader is fit for the mother of a future king,” Edinburgh. (Report filed)

Richard Tomlinson has also stated:

There’s an arrogant faction inside MI-6, part of the Eton/Oxford/Guards clique, who see themselves literally as defenders of the realm—and for them, that means the royals. When Di broke up with Charles, she immediately became the enemy. When she started a romance with Dodi Al Fayed, that raised an even more terrifying spectre.

What if she’d married him and turned Muslim? What if they’d had children? The thought of Prince William, the future King of England, with a brown-skinned Muslim half-brother or sister was the worst possible scenario for them. In their eyes, Diana would single-handedly destroy the fabric of the nation they (MI-5 and MI-6) were pledged to defend.

Backed by the Al Fayed millions, she could have set up a glittering rival court which would have made Buckingham Palace pale by comparison. She would have become the people’s Queen, so she had to go.

Mohammed Al Fayed had recently purchased the Paris Chateau previously owned by the Duke and Duchess of Windsor. This was the wedding gift he was going to give to Diana and Dodi. Tomlinson was right, the Paris Court of Diana and Dodi would have out-shined anything England could offer. Prince Phillip realized that his grandsons, William and Harry, would probably prefer spending time in Paris with their mother. This means that his grandsons would be influenced by “the son of a bedouin camel trader,” one that happened to be aligned with the age old enemies of the present British Throne. As Tomlinson says of the Palace:

The thinking would go like this: after Diana’s death the spotlight would turn back to the Palace, as it has; Prince Charles’ popularity rating would start to climb as he wins back public sympathy, and it has done. And, importantly, Prince William will be firmly under Palace control. Mission accomplished. No Di, no rival court. Monarchy secure.

If Richard Tomlinson lived in Geneva and was an MI-6 agent, then he probably knew the K-Team that lived in Geneva. Tomlinson has *never* said that Dodi, not Diana, was the target of the assassination team. *Nowhere* in the original MI-6 document does it say *anything* about killing Diana. What they had in mind for her would have been far worse than death.

Since Tomlinson believes that Diana was also the target, it appears that sometime in the two and a half months between the writing of the MI-6 document on June 17, 1997 and the assassination on August 30, 1997 a new plan was filed. Possibly this new plan was in one of the many CIA documents found in Oswald LeWinter’s Vienna hotel room. Because of Tomlinson’s connection to the K-Team in Geneva, perhaps he knew that the plan had been changed.

The Mossad Connection

In a book called *Gideon’s Spies*, the claim is made that a Mossad agent named Maurice was in Paris at the Ritz Hotel trying to recruit the chauffeur, Henri Paul, on the very day the accident occurred. Henri Paul, the driver, was killed instantly.

This book further states:

In July 1998, Mohammed Al Fayed asked a number of questions in a letter he sent to every one of Britain's members of Parliament, urging them to raise the questions in the House of Commons. He claimed that 'there is a force at work to stifle the answers I want.' His behavior was seen as the reaction of a grieving father lashing out in every direction. The questions deserve repeating, not because they shed any light on the role Mossad played in the closing weeks of Henri Paul's life, but because they show how the entire tragedy has gained a momentum that only the true facts can stop.

Al Fayed wrote of a "plot" to get rid of Diana and his son and attempted to link all kinds of disparate events with his questions: "Why did it take one hour and forty minutes to get the princess to hospital? Why have some of the photographers failed to give up some of the pictures they shot? Why was there a break-in that night at the London home of a photographer who handles paparazzi pictures? Why have all the closed-circuit television cameras in that part of Paris produced not one frame of videotape? Why were the speed cameras on the route out of film, and the traffic cameras not switched on? Why was the scene of the crash not preserved but reopened to traffic after a few hours? Who was the person in the press group outside the Ritz who was equipped like a news photographer? Who were the two unidentified men mingling in the crowd who later sat in the Ritz bar? They ordered in English, watching and listening in a marked way?

Gideon's Spies seems to be a clever way of sowing disinformation and covering the tracks of any Mossad agents who happened to have been involved in the murder of Dodi and Diana.

At the top of the MI-6 document the sources for the information are listed. One is a British citizen named Ken Etheridge. Ken Etheridge worked for one of Mohammed Al Fayed's enemies, Tiny Rowlands, who financed Allan Frankovich's film

"The Maltese Doublecross," about the downing of Pan Am 103. Rowlands financed the film for two reasons. One, he felt that he could drag Muslim terrorists and arms dealers into the film and thereby taint Al Fayed who was involved with arms dealers. The second reason was purely business. Rowlands wanted to get in good with Colonel Gaddafi in order to obtain mining concessions near the Chad border.

Rowlands sent Ken Etheridge to Spain to supervise the filming of DIA whistle-blower Les Coleman. Coleman stated that it was not the Libyans who downed Pan Am 103, it was Palestinian terrorists who were paid by Iran. This information put Rowlands in high regard with Colonel Gaddafi. According to CIA sources:

Etheridge was an Asset of MI-6 who had investigated Al Fayed some years back and who gave the CIA information about Al Fayed's weapons deals with his brother-in-law, Adnan Khashoggi. Etheridge's involvement with the Diana business is a round-about one in that he informed the CIA of the extent of Al Fayed's intrigues concerning his desire for a Dodi-Diana Union to the British Establishment, who has refused to grant Al Fayed citizenship for over thirty years.

Early Reports State Diana Was Out of the Car

Early television coverage of the accident stated that Diana was out of the car and walking around. The first reports to be seen on television said that Diana was "out of the car" ... "conscious" ... "suffering from a broken arm, a cut on her hip & a possible concussion." These reports stated that her injuries were "not potentially life threatening, but serious." These reports are part of an article by Sabre called, "Diana, Accident or Murder?" Sabre began taping at approximately 12:35 a.m. from a satellite feed, shortly after the first bulletin aired. Initial reports were from the BBC and SKY. These remarks and the photos that were aired with them have never been reported since.

Documents in the possession of the CIA state most of what has been laid out above. These documents were summarized for me by a CIA operative. In addition to stating many things that have been in the public domain for years, the documents also state the following. Some of the following information is so disturbing that it has taken me two full years to verify it and finally write about it.

- The target on the evening of August 30, 1997 was Dodi Al Fayed. The Palace had given its blessing for the elimination of Dodi Al Fayed, the father of the child Diana was carrying.
- The Palace assumed Diana was about three months pregnant.
- The original plan called for the death of Dodi AND an abortion for Diana!
- The Palace ordered an abortion using the D&C method. It was performed in the ambulance while it was parked for nearly an hour, on the side of the street, on the way to the hospital.
- The abortion was completed, but the loss of blood was too great and the advanced damage to internal organs was irreversible.
- Diana died of blood loss caused by an abortion – NOT from a torn heart!
- The coverup of the truth was ordered by Bernadette Chodron de

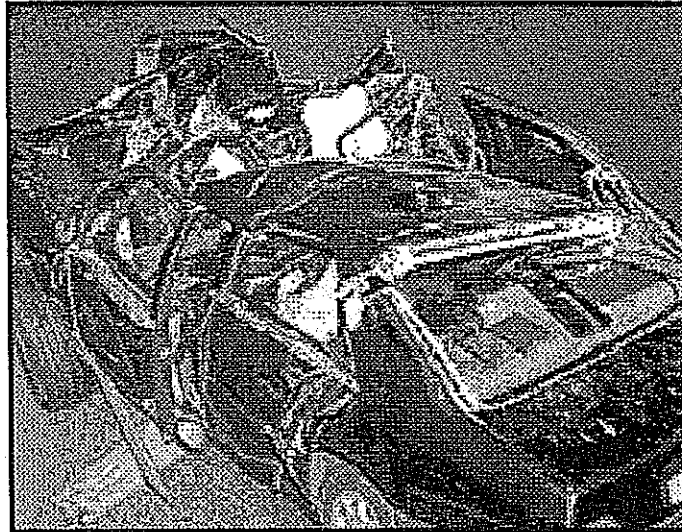
Courcel, the wife of President Chirac, who was informed immediately and sped to the hospital. Mme Chodron de Courcel is the power of Opus Dei in France.

- To insure that Dodi died in the crash, the K-Team had one of their "specialists" positioned inside the Pont de L'Alma tunnel. He was the one who reached into the car, as if he was checking to see if Dodi was alive. It is not known if Dodi was alive or dead when the "specialist" broke his neck. As he emerged from the car, he shook his head to let the members of his team, who were disguised as photographers, know that the deed was done. Dodi was dead.

- There is a photograph of the "specialist." It has been published in one of the tabloids, however, its significance was not known at the time.

- Diana was alive. She was outside the car, walking. She knew Dodi was dead. When the ambulance arrived, Diana stepped into it herself. There is a photograph which shows her sitting inside the ambulance. She looks fine.

While it is suspected that whoever performed the abortion was ordered to cause her death, this has not been confirmed. CIA sources state that the Palace did not want her dead. The Palace still hoped to use her to reunite Britain and the United States. The Palace also knew that secrets like this cannot be kept. If the Palace was involved in the murder of Diana, her two loving sons would eventually find this out. It was all right if William and Harry knew that the Palace, meaning their Grandparents, had ordered the death of their mother's Egyptian boyfriend. They knew they could make the boys understand why they did it. But the Palace could never

make Prince William and Prince Harry understand why their mother had to be killed.

If the Palace did not want her dead then who ordered it? And why? CIA sources have speculated that one or two men in powerful behind-the-scenes positions decided on their own that Diana was too much of a "loose cannon" to be trusted. These men decided it would be easier to control her if she was dead. Therefore, they arranged her death, so they could use her image to create a new world religion through which they could control the world.

Say the words "Mind Control" and most people think science fiction or lunatic fringe. Yet, as incredible as it may seem, mind altering technology is real.

The mind altering feat is accomplished by using standard radio and/or television broadcasts to carry an electronic subliminal message that is perceived by the subconscious mind. Another method directly alters the brainwave patterns of the recipient to induce specific emotional states. This subliminal carrier technology is described in U.S. Patent #5,159,703, "Silent Subliminal Presentation System." According to company literature, this technology has been leased out to six U.S. government agencies (including the U.S. Army's Psychological Warfare Operations), selected music and movie companies, and various other governments of the world, including Germany and former Soviet Union countries.

The U.S. Military has developed this highly sophisticated mind altering technology for use as a weapon. It was used during Operation Desert Storm against Iraqi troops to induce in them feelings of hopelessness and despair that resulted in "mass surrenders." The use of this Psy-Ops weapon was reported by ITV News Bureau (London) in two bulletins, dated March 23 and 26, 1991 but the U.S. press was subject to military censorship that suppressed this information.

In addition to land-based broadcasts, this mind-altering technology has been incorporated into USAF aircraft EC-130E, code-named Commando Solo. The USAF

acknowledges use of this technology in the following Operations: Urgent Fury, Just Cause, Desert Shield, Desert Storm, Desert Fox, Desert Thunder, Uphold Democracy, and Joint Guard. The last two were directed against civilian populations to influence elections in Haiti and Bosnia.

This mind altering technology is officially listed as part of the new "non-lethal" weapons. These non-lethal weapons are being transferred by the Department of Defense over to the Department of Justice to be available to the local police force.

Dr. Michael A. Persinger, a neuroscientist at Laurentian University, Canada has warned of the possibility of this technology being used for global mind control. Independent researchers have deter-

mined that the HAARP (High-frequency Active Auroral Research Program) in Alaska could be used to achieve this far-reaching effect. Dr. Igor Smirnov of the Institute of Psycho-Correction in Moscow says in regard to this technology, "it is easily conceivable that some Russian 'Satan', or let's say an Iranian or any other, as long as he owns the appropriate means and finances, can inject himself into every conceivable computer network, into every conceivable radio or t.v. broadcast with relative technological ease, even without disconnecting cables. You can intercept the waves in the aether and then modulate every conceivable suggestion into it."

In recognition of this threat, the Parliament of the European Union has passed a resolution calling for "an international convention introducing a global ban on all developments of weapons which might enable any form

of manipulation of human beings" as well as having the "new 'non-lethal' weapons technology... covered and regulated by international conventions." (Resolution A4-0005/99 "Environment, Security & Foreign Affairs," January 28, 1999) (see also Judy Wall in *Nexus*, 10/98 and 10/99.)

A Subproject to Boggle the Mind

At left is shown a "Memorandum for the Record, Subject: MKULTRA, Subproject 119," dated 17 August 1960, which states the following: 1. The purpose of this subproject is to provide funds for a study conducted by [redacted] to take a critical review of the literature and scientific developments related to the recording, analysis and interpretation of bioelectric signals from the human organism, and activation of human behavior by remote means. When initiated this study was being done on a consultant basis by [redacted]. Please note that these are mainly private inventions intended for positive uses, but could be applied for negative purposes as well. We have no idea what the government may have in classified research per the above 1960 memo:

- Silent Subliminal Presentation System, U.S. Patent #5,159,703, Oliver Lowery, October 27, 1992. A silent communication system in which nonaural carriers in the very low or very high audio frequency range or in the adjacent ultrasonic frequency spectrum are amplitude modulated with the desired intelligence and propagated acoustically or vibrationally for inducement into the brain.
- Hearing System, U.S. Patent #4,877,027, Wayne Brunkan, October 31, 1989. A method for directly inducing sound into the head of a person using microwaves in the range of 100 MHz to 10,000 MHz, modulated with a waveform of frequency modulated bursts. The bursts are

frequency-modulated by the audio input to create the sensation of hearing in the person whose head is irradiated.

- Psycho-Acoustic Projector, U.S. Patent #3,566,347, Andrew Flanders, February 23, 1971. A system for producing aural psychological disturbances and partial deafness of the enemy during combat situations.
- Noise Generator and Transmitter, U.S. Patent #4,034,741, Guy Adams and Jesse Carden, Jr., July 12, 1977. An analgesic noise generator.

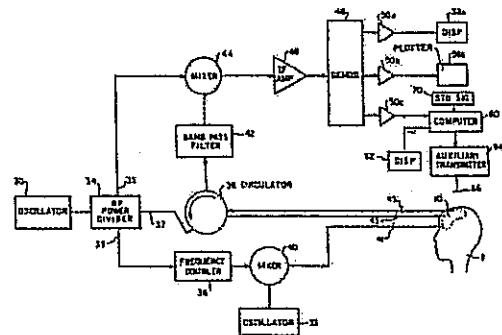

ABSTRACT

Apparatus for and method of sensing brain waves at a position remote from a subject whereby electromagnetic signals of different frequencies are simultaneously transmitted to the brain of the subject in which the signals interfere with one another to yield a waveform which is modulated by the subject's brain waves. The interference waveform which is representative of the brain wave activity is re-transmitted by the brain in a receiver where it is demodulated and amplified. The demodulated waveform is then displayed for visual viewing and routed to a computer for further processing and analysis. The demodulated waveform also can be used to produce a compensating signal which is transmitted back to the brain to effect a desired change in electrical activity therein.

Timmy McVeigh Was Telling the Truth!

It's Not Your Father's Mind Control Technology

When those of us who have been researching and investigating rumors of microchip implants for the last 10 years heard that Timothy McVeigh was claiming to have been implanted by the U.S. Army, we could only nod our heads. (1) The mainstream could barely contain their laughter at McVeigh's allegations of being implanted by the military. They pretended he was another "lone gunman."

However, many researchers knew that it was not above our government to use unwitting American citizens in "field testing." There had been reports from private citizens since the 1940s of the implantation of humans. (2) The only thing we could add to McVeigh's statement was that before the microchips were implanted by the military in soldiers it was suspected that there were many years of covert testing in an unwitting human subjects. In recent years, government documentation has been released showing past and present atrocities committed by the U.S. government and its contracted private corporations funded by public monies. These documents show a pattern of utilizing unwitting citizens in covert "field testing."

The possible proof that McVeigh was speaking the truth is suggested in public documents. A document which proves that the military is quite familiar with microchip implantation in human subjects is pointedly referred to in the U.S. Air Force's 2025 Research Paper (3), quoted as follows:

Chapter 4-1: IIC

The IIC is a constellation of integration or "smart" satellites that receives all-source information. Within the IIC, resident intelligent software will run decision support tools, correlate and fuse

data into useful information, identify inconsistencies and information gaps, and task collectors to seek data to fill information gaps.

Implanted Microscopic Chip

The implanted microscopic brain chip¹¹⁰ performs two functions. First, it links the individual to the IIC, creating a seamless interface between the user and the information resources (in-time collection data and archival databases). In essence, the chip relays the processed information from the IIC to the user. Second, the chip creates a computer-generated mental visualization based upon the user's request. The visualization encompasses the individual and allows the user to place himself into the selected battlespace.

Do not be fooled by its forward-looking statement. That statement would not be made if the technology were not already in place. Remember the above statements as we put the pieces together to show control of individual via electronic harassment. The following statement from the same source more directly relates to McVeigh and other soldiers whom I have heard from during my investigations:

Ethical and Public Relations Issues. Implanting "things" in people raises ethical and public relations issues. While these concerns may be founded on today's thinking, in 2025 they may not be as alarming. We already are evolving toward technology implanting. For example, the military currently requires its members to receive mandatory injections of biological organisms (i.e., the flu shot). In the civilian world, people receive mechanical hearts and other organs. Society has come to accept most of these implants as a fact of life. By 2025 it is possible medical technology will have nerve chips that allow amputees to control artificial limbs or eye chips that allow the blind to see. The civilian populace will likely accept implanted microscopic chips that allow military members to defend vital national interests.

Further, the US military will continue to be a volunteer force that will freely accept the chip because it is a tool to control technology and not as a tool to control the human.”

I hardly know what to make of that last sentence. After all the reassurance that microchip implantation is good for you, why make statements about controlling humans? Could the authors be anticipating that some readers might think the microchip would be utilized for human mind control; i.e. readers who are knowledgeable enough to know that the brain cortex needs to be accessed/controlled in order to control the physical part of the human? There is no way to separate physical control from mind control. Such powerful technology that can control humans invites misuse; pushing the envelope to see what will work. (Perhaps, creating the perfect crime using a “patsy”?)

For those still doubting that this type of mind control technology (which utilizes a radio frequency called microwave) is just science fiction, an announcement was made on a mainstream public radio station that the Los Angeles Police Department, just before New Year’s – in December, 1999, had purchased equipment from a company called WesCam. From the WesCam website we read the following:

In use by most of the biggest names in broadcasting in the U.S. and abroad, the PRO-300 has become the industry standard in long range, microwave receive systems for reliable, continuous, high quality reception of video and audio transmissions. The antenna is typically installed on a tower or rooftop at a location selected for best continuous line-of-sight coverage to the potential transmitting sites (terrestrial and / or airborne). The equipment rack containing the microwave receiver and controller can be located up to 1,500 feet away, and the control location can be situated just about anywhere to which video, audio and data links can be established.

Related TouchStar options now available include integrated searchable maps (dependant on location), networked Master Controllers, on screen Real Time Video window, remote access modems enabling a remote diagnostics capability, integrated single or multiple ground camera control, and remote switcher control.

These advertising statements mean that there is now a link between satellites, ground control and covert accessing of humans. As alluded to by the U.S.A.F. 2025 report, the American public is being utilized in “field testing” with the clear prospect of collecting data on the targeted individual. What is more important is that the Los Angeles Police Department, along with other major cities’ police departments, has been declared an arm of the Department of Justice.

I have personal knowledge of this fact. How that happened had nothing to do with the war on drugs. Briefly, it was alleged that I was jaywalking. I was not carrying any identification on my person. Therefore, I was detained by the University of California-Los Angeles Campus Police and taken to their campus headquarters. After being kept in a holding cell, I was photographed and fingerprinted. When asked where this mate-

rial was going to be filed, I was told that it would be sent to the Department of Justice. And, yes, there is now a law on the books that individuals must carry identification at all times. Originally, this law applied only to drivers of vehicles. Apparently, the law is being stretched to cover pedestrians walking on the sidewalks. Unbelievable? If someone had told me such an incident was possible, I would not have believed it.

We have President Ronald Reagan to thank for the fact that local police departments are now arms of the federal government. This includes university campus officers. Just to make sure that Reagan’s executive order was clear to everybody in law enforcement, the U.S. Code was “updated” recently. (U.S. Code Annotated Title 10, Sect. 124.)

To help local law enforcement stay abreast of the activities of the American public, just in case citizens were doing drugs or something else that might be illegal, monies were allocated to allow those units to carry out the U.S. Code for the Department of Justice. The following is from the WesCam website(4), which describes a tracking unit mounted on a helicopter, used no doubt to watch everybody and anybody without a search warrant, wiretap, or any messy legal stuff:

The SKYPOD V airborne microwave system is the next generation of long range airborne video microwave transmission and relay systems from WesCam, providing reliable, continuous, high quality video and audio signals in real time to fixed or mobile ground receive sites. The system includes an externally mounted antenna pod integrated with its own microwave transmitter, receiver, channel filter and up to three separate antennas: an autotracking directional high gain antenna (using GPS and aircraft heading sensors for tracking control), an omnidirectional antenna and a downlooking antenna. This configuration provides maximum operational flexibility while still maintaining optimum signal quality for superior image transmission. Antenna selection is performed remotely from the operator position inside the aircraft. Each antenna can be configured for simplex or duplex operation, allowing the system to also be operated as an airborne microwave repeater.

The announcement declaring that the Los Angeles Police Department would be watching Los Angelenos using WesCam technology was mentioned only once on a major public radio station in Los Angeles, presumably to meet the U.S. Code that requires local officials to make a public announcement before using the public in “field testing.” Section 1805 of Title 50 of the U.S. Code (5) reads as follows:

(f) Testing of electronic equipment; discovering unauthorized electronic surveillance; training of intelligence personnel. Notwithstanding any

other provision of this subchapter, officers, employees, or agents of the United States are authorized in the normal course of their official duties to conduct electronic surveillance not targeted against the communications of any particular person or persons, under procedures approved by the Attorney General, solely to – (1) test the capability of electronic equipment, if – (A) it is not reasonable to obtain the consent of the persons incidentally subjected to the surveillance; (B) the test is limited in extent and duration to that necessary to determine the capability of the equipment; (C) the contents of any communication acquired are retained and used only for the purpose of determining the capability of the equipment, are disclosed only to test personnel, and are destroyed before or immediately upon completion of the test; and: (D) Provided, That the test may exceed ninety days only with the prior approval of the Attorney General; (2) determine the existence and capability of electronic surveillance equipment being used by persons not authorized to conduct electronic surveillance, if – (A) it is not reasonable to obtain the consent of persons incidentally subjected to the surveillance; (B) such electronic surveillance is limited in extent and duration to that necessary to determine the existence and capability of such equipment; and (C) any information acquired by such surveillance is used only to enforce chapter 119 of title 18, or section 605 of title 47, or to protect information from unauthorized surveillance; or (3) train intelligence personnel in the use of electronic surveillance equipment, if – (A) it is not reasonable to – (i) obtain the consent of the persons incidentally subjected to the surveillance; (ii) train persons in the course of surveillances otherwise authorized by this subchapter; or (iii) train persons in the use of such equipment without engaging in electronic surveillance; (B) such electronic surveillance is limited in extent and duration to that necessary to train the personnel in the use of the equipment; and (C) no contents of any communication acquired are retained or disseminated for any purpose, but are destroyed as soon as reasonably possible.

Notice the statement “if consent cannot be obtained,” and the statement that electronic technology will be used only for the purposes of “testing.” If it is just a test, why is there a problem with obtaining consent? How about the statement that nothing will be done with the information gathered from “testing”? Are you reassured by these paragraphs in the U.S. Code? I understand this: There is a group of people claiming they are/have been under electronic surveillance/harassment. Are these people classified as guinea pigs for government field testing, or perhaps even as terrorists? If individuals are classified as “terrorists” (whether they truly or not), this means that they can be targeted in any way shape or form, because they are enemies of the state. Therefore, is it okay to do whatever – torture, harass, etc. using microwave technology – in the

name of “field testing”? Is the American public so fearful of possible crimes that they would give up all their privacy?

WesCam is microwave technology that can “access,” listen in on conversations, using RF/microwave radiating through walls at a distance. The dome-like shell surrounding the equipment is shown on their website. The device is mounted on the roofs of vans, the roofs of police stations, and on the undercarriage of helicopters. Be sure to watch for this equipment coming to a neighborhood near you. A fellow researcher sent me a list of 20 outlets for the WesCam in the Los Angeles area. That means your next door neighbor can, and probably some of them will, own this equipment.

Along with WesCam, there is a company called Millivision that sells “infrared” equipment which it claims can “see” through walls. The Millivision website(6) states the following:

Millimeter wave technology offers the opportunity for developing a new generation of security and safety products. Millimeter waves can pass through walls, clothing, and packaging to detect hidden people and objects. Not limited to metal, millimeter-wave-based systems allow the detection of ceramic weapons, plastic explosives, drugs, and other contraband. Millivision is developing a line of passive millimeter wave security products that are: Non-invasive: Passive systems use only the natural radiation present in the scene. Safe: Using no man-made radiation ensures complete safety for subjects, operators, and bystanders. Difficult to countermeasure: Inanimate objects emit different radiation signatures than living beings, making attempts to disguise contraband ineffective. Effective: Advanced imaging software overcomes resolution and visualization limitations.

Millivision’s line of passive millimeter wave security products currently in development are: Surveillance camera – overt or covert monitoring and contraband detection in interior or exterior spaces; Gateway scanner – contraband and concealed weapons detection for secure portals; Handheld scanner – portable contraband and concealed weapons detection.

Feel safer now that Millivision devices are on the scene? Wondering whether that passing van is scanning your house? Do you think this will not happen because you think you have nothing to hide? Think again.

The Los Angeles Airport claims it owns one of these devices. Checking individuals to see if they are . . . what, carrying guns after going through the metal detector? After news of this device was published in the *Los Angeles Times*, people were concerned that the device was being used to see through women’s clothes – just for the fun of it. As a matter of fact, a recent TV news program discovered that airport security personnel do single out Los Angeles African American women traveling alone for

questioning in a special room at the Los Angeles Airport. There was concern that this was the room where the Millivision device was located. The suspicion was confirmed by Los Angeles Airport Security with the promise it will never happen again.

Just recently, in the mainstream press, there was public outrage over a satellite system called "Echelon." The sinister nature of this satellite has produced a group called "Echelon Watch" run by the ACLU.(7) This satellite system has generated hearings in Western governments by legislators who want to know Echelon's capabilities, as well as how to stop it from spying without regard to national boundaries or nationality of targeted individuals. But long before there was Echelon there was the National Reconnaissance Organization's (NRO) Rhyolite satellite system.(8) This was part of a group of satellite technologies referred to as ferrets, designed for electronic surveillance. All of the world powers have had satellite spy systems since the early 1960s.

In February of 1997, the *New York Times* published an article by William Broad called "Private Ventures Hope for Profits on Spy Satellites," ("Privacy is seen as Issue; Images Can Show Warships or Hot Tubs, Halting a Long Government Monopoly"). The article informed readers that a new policy allowed them to request satellite images and pay for them with a credit card. It was claimed by federal officials that "the risks and benefits were carefully weighed before the 1994 decision and that economic gains will offset military or diplomatic losses." A vibrant economy, they say, is "one of the most important elements of national security." Does the preceding statement anticipate the trading of satellite technology with the Chinese? With the claim that so-called "leaks" of this technology "bring about a new age of peacefulness"? Or, the more realistic stance that this technology will allow accessing any individual anywhere on Earth.

Because of the interest in espionage from space, ultra long distance high altitude accessing optics were developed and installed in satellites. The most recent public access satellite company is IKONOS(9). The one-meter resolution black-and-white image of Washington, D.C., collected by Space Imaging's IKONOS satellite, has unprecedented clarity and detail for commercial space imagery. As the IKONOS web site sales pitch goes: "The potential uses for IKONOS imagery are vast and we have just begun to scratch the surface. The value of this new source of information will create a demand like we've never seen before for imagery of the Earth." So, if you have the money, this company will spy for you. This technology can search for the target, capture their images and relay the image to a ground base in real time. Please be aware that this is merely the latest technology that has been allowed to go public.

Let's recap: The technology has been around since the early 60s which transmits and receives imagery from space; human implantable transmitters/receivers have been in development since the 50s; and experimental "field testing"

using its tax-paying citizens has been a regular activity of the U.S. Government – and the British and Russian governments. How do we directly link the above technology to a targeted individual (TI) on the ground, esp. since so far no "smoking gun" document has been found? And, how is it possible to manipulate the TI physically and access the human mind to implant ideas/commands? Let's start with a brief history of telemetry and monitoring of humans. The following quotes by Dean C. Jutter are from *Engineering in Medicine and Biology*, dated March 1983(10):

In 1903 Einthoven transmitted electrocardiogram voltage over Leiden Telephone System wires about a mile to a string galvanometer. In 1921 Winters transmitted heart sounds over a marine radio link as a demonstration for ships without a physician. External transmitters of various signals evolved as electronic methods evolved to produce smaller transmitters. Later, several groups inserted small coils and electrodes into the skulls of animals so alternating currents could be induced for a primitive form of telestimulation.

Stuart Mackay was in biotelemetry from the very beginning and gives us a glimpse of the early developments and evolution of the field. Dr. Mackay's message is replete with examples and applications to an impressively wide variety of animal species. Miniature and micropower are two cornerstones of modern biotelemetry design and construction. Improvements in these areas have closely paralleled the evolution of semiconductor and microcircuit technologies. He has been involved with reliable, stable integrated sensors and biotelemeters on microcircuit designs and implementations in recent years. The works is truly state-of-the-art.

Eli Fromm has provided an example of a "poor man's" hybrid biotelemeter to illustrate that some rather sophisticated circuit operations can be done on a low budget and without extensive microcircuit capabilities. His comments focus on a design for a two channel, FM-FM formatted implanted biotelemeter for multiple channel monitoring using resistance type transducers. Biomedical telemetry like many other things began as a "laboratory curiosity" but has evolved to a useful, reliable tool for data gathering. It has become an important, often complex, part of physiologic monitoring, but it also can be exciting and a lot of fun.

The scientists who worked on this study, I am sure thought their research would be utilized for the highest and most ethical purposes. Jutter's paper was published in 1983; however, it probably took 5 years to reach publication. The following paragraph from this previously cited paper provides a clue as to how many years this technology had been in development/research:

The transmission of signals from within a subject was a technique that evolved slowly. On July 2, 1952 William Shockley and Bell Labs sent me [Dr. Jutter] four experimental point-contact transistors, which were difficult to power in a small package. (Junction transistors were only available for military use.) Thus, another approach was developed to provide for the totally passive transmission of information. Figure 2 is taken from Markevitch's 1954 undergraduate research report. The tuned circuit could be placed in the mouth and its frequency monitored from outside the face by the grid-dip meter. Thus the circuits tested by Markevitch showed that signals could be transmitted through the tissues of the body from quite small coils placed within the body.

The closing paragraphs of the journal article discuss implants:

Implantable transducers. With this type of package, the biomaterial must meet two basic requirements. First, it must protect the device from the influx of body fluids; second, it should provide minimal interference with the transduction of the desired signal. In packaging most biomedical transducers, an insulating conformal layer is deposited onto the device - in particular, over electrically conductive and potentially corrosive areas. The material (usually an adhesive rubber or resin) provides a thin, but tough, film capable of guarding against environmental effects. Also, foreign material or bacteria may remain on objects if the parts are not adequately cleaned beforehand.

A minimal weight is required for any implantable package. The pressure (amplitude, duration, etc), produced by the implant on the surrounding tissue may alter the blood circulation at the implant site, possibly affecting tissue reaction. One reason titanium is used commonly as an implantable metal is because it possesses a low specific gravity and an excellent strength-to-weight ratio compared to other metals such as tantalum, tungsten, and stainless steel. Blunt corners and sharp edges should be eliminated because they irritate tissues locally. A streamlined contour is desirable. Implant location and implant technique also influences the local reaction at the site.

The article also provides a chart with "Biomedical frequency allocation in the United States for Research and Patient Monitoring." The following citation from this 1981 report by the US electronic research provides details of the types of implants that were available for study in 1981(11):

Microelectronics has made possible immensely complicated feed-back and logic controls, so consequently the current difficulties lie primarily in the detecting and sensing aspect of the system. . . . There are reports in the literature regarding the development of other prosthetic devices such as pain suppressors,

urological controllers, blood sugar measurement for diabetic control, auditory prosthesis and intracranial pressure measurement. This is not a complete list of devices currently being developed, but merely an indication of the wide variety of prostheses that will be available in the future. . . . Telemetry systems with multiple sensor inputs, but with a single radiofrequency transmitter link are also available. The sophisticated microelectronics currently available makes the electrical amplification and signal condition relatively easy.

The above citations provide documentation that the specific knowledge and technology for accessing various physical systems in humans has been available for many years. What about accessing a human mind to manipulate it? Dr. Jose Delgado was the first publicly recognized scientist to implant an animal and manipulate it from a distance. Based on Dr. Delgado's work, other research scientists came later. For example, the following is from a paper discussing manipulation of human emotions by researchers in 1978 at the University of California-Los Angeles (12) possibly utilizing, in addition to patients, volunteers from the Reed Brain Institute's Sleep Lab:

Electrical stimulation of the human brain may evoke reports by patients of a wide variety of simple and complex sensations, emotions, and cognitions. These mental phenomena have been primarily considered in relation to the localization of function within the human brain. Penfield, in his pioneering studies describing the mental phenomena evoked by stimulation of the human temporal lobe, interpreted these evoked phenomena in a manner analogous to those evoked by specific sensory cortex stimulation. Penfield found, and others have confirmed, that the most common categories of mental phenomena evoked by temporal stimulation include complex hallucinations. When discussing the hallucinations, which he considered to be memories, Penfield labeled the temporal cortex "memory records" (Penfield and Jasper, 1954, p. 145). When considering the *deja vu* or other misinterpretations of present sensations, Penfield (1958) referred to this cortex as "perceptual" in analogy to "visual" or "motor" cortex, because stimulation there evoked "psychical responses" corresponding to the visual sensations or movements evoked by stimulation of the specific cortices.

The closing paragraphs of the above article suggest that, if required, emotional phenomena can be stimulated by directly accessing the temporal lobe electronically. As this paper states:

Most of the mental phenomena reported by our patients during temporal lobe stimulation could be categorized as a hallucinated image or scene, an emotion, usually fear or anxiety, a visceral sensation, usually epigastric, or an informed sensory sensation (visual, auditory, or somesthetic).

Of 3495 stimulations of the medial temporal lobe of 36 psychomotor epileptics, 266 were accompanied by reports of mental phenomena, including hallucinations of complete scenes, *deja vu*, anxiety, visceral sensations, amnesia, and uniform sensory experiences. Olfactory and frankly aggressive responses were not observed. Our findings suggest that, in contrast to the primary visual or somatosensory areas, where the evoked mental phenomena are highly predictable and are closely related to the anatomical site, the mental phenomena evoked by medial temporal lobe stimulation are idiosyncratic and variable, and are related to the personality of the patient stimulated.

In light of the research cited above, it is possible to explain remotely controlled hallucinations or synthetic scenarios referred to as virtual realities. But, how can a targeted individual hear "voices" from external sources? Over the years, even though it appears the research went "black" in the early 1980s, information has come forward, usually in academic journals. One of the breakthrough papers, authored in 1962 (13) by Allan H. Frey, entitled "Human Auditory System Response to Modulated Electromagnetic Energy," is the link. This was *the* breakthrough. It must have been like watching movies for the first time. People made of light moving across a wall. . . Only this time, people in a laboratory could "hear" without a radio/transmitter. What they heard at first was only clicks and buzzes. The operator controlled the clicks and buzzes. Dr. Frey had figured out how microwave signals created sound in the head of a target.

In 1975, Dr. Don R. Justesen published a paper in the *American Psychologist* called "Microwaves and Behavior." (14) This is the only journal article mentioning an experiment by Dr. Joseph C. Sharp. Dr. Sharp does not seem to have published the results of his experiment anywhere. Or, maybe, he requested not to. Following is the quote from Justesen's paper regarding the experiment:

Sharp and Grove (note 2) found that appropriate modulation of microwave energy can result in "wireless" and "receiverless" communication of speech. They recorded by voice on tape each of the single-syllable words for digits between 1 and 10. The electrical sine-wave analogs of each word were then processed so that each time a sine wave crossed zero reference in the negative direction, a brief pulse of microwave energy was triggered. By radiating themselves with these "voice modulated" microwaves, Sharp

and Grove were readily able to hear, identify, and distinguish among the 9 words. The sounds heard were not unlike those emitted by persons with artificial larynxes.

The research results discussed in Sharp's paper prove that the human being has had the capacity for many years to receive audible signals without being implanted. It should be apparent that humanity has had both the technology and the will to manipulate each other remotely. Information about the possibility of mind control has surfaced with regularity every few years. Yet, there is no public outcry en masse of the incredible invasion of privacy, and emotional and physical manipulation of everybody on the planet. In the next installment we will look at the possible reasons why there is no angry public demanding an end to this technology.*

I am a survivor of intelligence cults that operate across Canada and are connected internationally. In 1959, I was born into an intergenerational CIA-connected cult that continues to operate in central Ontario. I was first subjected to calculated torture sessions in the womb, and have been able to integrate fetal selves as an adult. I was an experienced dissociater at birth, an accomplished prostitute before kindergarten, and was being circulated on an elite international circuit by grade school. My programming involved fragmentation into alters who were trained as sex agents, couriers, computers, and cult alters (priestess, seeker, caller, whore, slave, trainer, etc.). Some of my alters were trained to handle weapons. The stories of Kathleen Sullivan, Brice Taylor, Cisco Wheeler, and Claudia Mullen, as well as Cathy O'Brien's *TranceFormation of America* describe much that is familiar to me, including near-death centers and 'hunting.' I would like to thank each of these women for speaking out. I deeply admire your courage. Keep going.

My perspective differs somewhat from the women mentioned above in that I have experienced a great deal, both personally and through recovered memory, of the metaphysical. I do not believe occult ceremonies are based solely on superstition and programming. It is my understanding that both cults and the intelligence network are developing the technology to exploit the metaphysical realities that are a daily part of all our lives, and that they intend to use these metaphysical realities to fragment and radically realign the consciousness of the average citizen for purposes of 'mind control' and to 'feed' off the energy of each individual life. I would like to discuss this as a complex process that aligns the brain to specific frequencies, then uses calculated trauma and dissociation to force interaction with the metaphysical. This interaction is then programmed for specific purposes by the intelligence community.

First, however, I think it important to note the basic motivation that drives mystery cults to perpetrate their heinous illegal activities: the desire to live forever. In search of immortality, cults have always explored metaphysical gateways to alternate dimensions that can be opened through traumatic dissociation. These out-of-body experiences teach cult members to exist as frequencies; conscious knowing energy that has been dissociated from the body during trauma. One can leave the body at many different frequencies, and each frequency opens up a different dimension of reality or 'mystery,' as well as interaction with the entities which inhabit these dimensions.

Members of mystery cults have also learned to exploit the human energy of others as 'feed,' extending their own longevity within the body. They have learned to transmit more and more of their consciousness into alternate dimensions (some are called Heaven, Hell, the Mysteries, etc.), where their 'spirits' will live after their bodies die, so that they are 'storing up their treasures' not on earth, but in alternate 'spiritual' realities. These dissociated 'spirits' are composed of energy and continue to exist only as long as they are 'fed' through the kill energy of human sacrifice. If not, they fade as all energy fades, because human beings are not meant to live forever.

It is my understanding that the intelligence community has been developing the technology to explore and facilitate this process. While their goals are much more complex than the desire for immortality, this is one of the many different aspects of consciousness which they have been attempting to technologize and control. Everything that they eventually accomplish, however, begins with the process of dissociation.

Dissociation is commonly experienced during trauma. Rape and traffic accident survivors describe out-of-body experiences during which they float above their bodies and watch terrifying activities transpire below. This experience occurs naturally, whether the actual trauma is a fluke occurrence or a calculated torture session. What I have come to understand, based on a decade of recovery,

is that the traumatized mind of a young child doesn't just send itself upward to escape. It can dissociate in one or all six directions simultaneously. As I grew older, the number of escape routes into which my mind projected itself increased into the hundreds, even thousands, but to a very young mind, there are only six immediate directions to leave the body, and this is the reason the number six is basic to cult primary programming.

After consciousness projects itself out-of-body to escape trauma, it continues to exist. A dissociated fragment of consciousness (an alter) can watch and think, remember and record what is happening to her body as she hovers above, beside or below it. (Many survivors can remember a single torture session from several out-of-body perspectives. These tend to be less affected by pain, shock, drugs or virtual reality headsets because they no longer reside within the body. This is the source of the majority of recovered memories – dissociated alters who have been projected out-of-body.) When the trauma ends, and the body is free from pain and fear, these fragments of consciousness will probably return to it. If the incident of pain/fear is not repeated, the dissociated fragments of consciousness will most likely merge with core consciousness and there will be no long-term loss of memory.

The reason most people commonly remember dissociating upward during trauma is because Up is the easiest out-of-body dimension to recall. The human body naturally lives within many interactive dimensions of reality, but Western society has programmed the individual to limit consciousness to the small fragment of reality we commonly call 'the real world.' Many people who dissociate and have an out-of-body experience will describe a great deal of activity going on 'around' us. The term 'Around' is a common cult trigger that refers to alternate dimensions, and it is frequently used to trigger an individual into sending a programmed fragment of consciousness (an alter) out-of-body, in order to initiate interaction that exists at a frequency outside 'real world' consciousness.

We are electric beings. Consciousness is a form of energy that is naturally coded into many different frequencies. These frequencies of consciousness align with the many alternate dimensions of reality we live within. Thus out-of-body states can occur at many different frequencies of consciousness. When consciousness leaves the body, it becomes a form of energy, a set of brain waves that has been projected outward. This energy, or brain frequency, can change as it travels. Consciousness that is projected upward leaves the body as quick warm vibrations. As consciousness travels upward, the vibrations quicken and grow warmer, the colors of the vibrations change from pastels to white light, and sounds are emitted at higher and higher pitches. The dimensions through which this projected consciousness travels also correspond to these changing frequencies.

I clearly recall ECT torture sessions at a doctor's office in which I was told by the doctor to send myself upward.

Before the electric shock was applied, I would be told a story about the dimension in which I was supposed to relocate after I left my body. For example:

"Up Up Up is a land of angels," he (the doctor) says. "It's a land where everything is white and clean. The angels are friendly and they sing happy songs. They play harps and sit on clouds. There are many white crosses there. When you go to Up Up Up, you'll be happy. There will be no devils and there will be no dark." (*The Only-Good Heart*, Goobie, p. 45)

As electric shock was applied to send me upward, a carefully choreographed scenario would often take place around me. For example, a man dressed as a devil might come running into the doctor's office:

"Then the door to the Operating Room bursts open and a devil comes in. A devil all dressed in black with horns on his head. The nurse screams, waving her hands. 'Gotcha,' the devil yells at me. 'Gotcha, Dorell. Gotcha.' I'm jerking from the electricity so I can't watch the devil jump all around me with his pitchfork. The doctor keeps saying, 'Up Up Up.' It starts to happen. As if I'm a white sheet pinned to a clothesline and the clothes pins come loose and a wind picks the sheet up slow, lifting me higher and higher, away from where I'm tied down, away from the electricity. Now, it doesn't hurt no more. It's easy, I lift into Up where I been lots of times. (*The Only-Good Heart*, p. 45)

As I traveled upward, I found myself passing through levels of out-of-body consciousness. The first level, which I was taught to call 'Up,' existed just under the office ceiling. There I was able to float free of pain and fear, and watch as the doctor and nurse applied further electric shock to my pre-school body on the table below. However, I wasn't alone as I floated in 'Up' and watched my body – other dissociated fragments of consciousness were floating there with me. One belonged to the doctor, one to the nurse, one to the man dressed as a devil, and there were several who looked like me and seemed to live there permanently; each of them watched what was taking place below. When they talked to each other, their voices were slightly higher than normal.

As more electric shock was applied to my body, I traveled further upward, passing through the ceiling into the next level which was called 'Up Up' – a sky-blue dimension full of dissociated fragments of consciousness belonging to familiar and unfamiliar people, all of them floating peacefully. These fragments looked like human bodies but had a spirit-like quality, and their voices were slightly higher and faster than voices in 'Up.' The next dimension, 'Up Up Up,' existed at a white-light frequency that was also peaceful and populated with human-looking

high-voiced angels, some of whom looked like me. However the level above this was a dimension of 'pure white fire' and extremely difficult to endure. The white figures of 'angels' could be seen traveling up and down from this level, which was called 'God,' a collective dimension of the projected psychic energy of electric shock.

In later ECT torture sessions, I traveled past 'God' into dimensions of outer space where I floated among stars and planets. Again, I found other fragments of human consciousness in these dimensions, though not as many. The doctor who controlled the ECT sessions programmed my out-of-body consciousness to return to my body when a specific tactile trigger was applied to my body. When I returned, he would have me report everything I had seen and experienced while traveling out-of-body. Gradually I realized he couldn't, or wouldn't, travel as far as I did, either because he didn't want to experience the level of electric shock it took to dissociate that far, or because he was unable to project psychically as far as I was.

I learned that the immediate dimensions surrounding me could change, depending on the room I was in and the people in the room with me. However, these dimensions remained collective and interactive – they could be entered by anyone who 'tuned into' them. A few of these upward dimensions had specific names such as Heaven, Seventh Heaven, Paradise, City of God, the Emerald City, or Narnia. Many involved flying unicorns, butterflies or rainbows, as well as settings from children's books and television shows.

I also experienced torture sessions in cold dark rooms that often involved being hung upside-down or placed inside coffins. I would be ordered to 'go Down' – i.e., project my consciousness downward. The mind travels downward in slow dark frequencies that commonly trigger interaction with psychic dimensions of graveyards, tunnels, caves, demons, vampires or ghosts. These dimensions are as interactive as white-light dimensions – i.e., dissociated fragments of human consciousness already inhabit these levels, taking the forms of vampires or demons, just as they took on the forms of spirits and angels in the white-light dimensions.

It has been my experience that avoiding the typical value judgements placed on dark and light psychic realities is essential to healing. These dimensions are about frequencies of consciousness, not good and evil. They exist naturally, but are exploited by cults as a method of 'storing' memory and consciousness as an energy source that the cult elite and non-human entities then feed upon. In order to accomplish this, cults carefully split and regulate a young child's 'in-body' and 'out-of-body' awareness, through the fragmentation and storage of consciousness in polarized dimensions such as Up and Down, Heaven and Hell, castles on the clouds and graveyards.

Cults have always used trauma-based programming to force their members to send fragments of consciousness

into aligned dimensions. In the sixties, intelligence cults became the guinea pigs for the technology that was being developed to enhance and control this process. The intelligence community was learning as it experimented, and the early stages were extremely blunt-edged, the goal being the creation of a quick and reliable dissociative response in the child through calculated episodes of trauma. The basic lesson a child had to learn was that it was preferable to exist not in the body, but in the psychic out-of-body dimensions of the mind. As an infant, I was often left in a brightly-lit cold room for long periods, naked, lying in my own feces and urine, while tape-recorded sounds such as grinding gears were played at a loud volume. My infant selves learned to respond as intended:

"And I know wanting. Wanting, wanting. I overflow my skin with sobs, wails I send out in search of mother hands, mother voice. Rooted in heart and the tips of nerves, a tiny longing energy floats around me. Against this, the huge grinding noise cuts deeper. The Body opens into a raw red wound. The longing released. Vague baby shape, transparent as a wish, the longing hovers a moment over the three-day-old infant's Body spread naked and wailing, then drifts around the room. Wishing mother hands, wishing mother voice. The open doorway, too far for The Body's eyes to bring into focus, comes close-up into the longing's gaze. This is the first door: escape from grinding sound, burning skin, the overwhelming light. Through the doorway into a hallway, immediately shadowed, the horror of sound and light placed further back. Lost, the longing drifts in the upper hallway where every other door is closed, then floats down the long stairwell of the old house to the first floor. There are different sounds at the end of this hall and the longing travels through another open doorway into a large white kitchen. Here a woman stands at a stove cooking soup." (*The Only-Good Heart*, p. 19)

As I grew older, I was frequently gagged and tied in my highchair, then left for hours. After I had stopped struggling to gain attention and was slumped unresponsively with glazed eyes, I would be fed and bathed, but only after I had learned that in the body I was nothing, I did not exist, no one would respond to me or love me. What I soon discovered, however, was that if I left my body and projected upward, a loving out-of-body version of my mother was waiting in 'Up' to care for me there. Very quickly I learned that mother-love, human love, and God's love all existed *upward*, out-of-body in the 'spirit' world.

To further ingrain this lesson, my abusers maintained a constant assault on my body that took many forms – emotional, physical and sexual abuse, immersion in water, spinning, heat and cold, flashing lights, and loud sounds. Pins and needles were inserted into my skin and genitals in specific patterns that correlated with acupuncture and acupressure techniques. Often the torture was over-

stimulation. One ritual involved many robed people standing around me, each rubbing a fingertip in a gentle circle on my skin. Fingers were also inserted into my mouth and vagina. Voices would whisper different messages into each ear at different speeds and pitches. To escape the confusion and over-stimulation, I learned to use the circling motion each fingertip left on my skin as a gate, and to leave my body simultaneously through each one.

Programming to fragment my spatial perception enhanced the dissociative process. In one scenario, I would be told to take a step to the right. As I took this step, my trainer would snap his fingers, creating an auditory break in consciousness. Then I was told my name had become 'Rightie.' When ordered to take a step to the left, my name became 'Leftie.' Pushed to the floor, I was given the name 'Downie'. There was also an 'Uppie,' a 'Backie,' and a 'Frontie.' Predictably, Rightie, Uppie and Frontie had positive experiences, while Leftie, Downie and Backie had negative ones. (The polarized good-bad functions of the six directions were reinforced in many different ways. For instance, I was often told that if I turned around *inside* my head, threw my bad memories into the dark, then turned around to the front and opened my eyes to see the light, the bad memories would be gone.) Electric shock was added to the finger snap, increasing the break in consciousness, until these six 'direction' alters were divided from my in-body consciousness by a wall of energy composed of electric-shock, pain, and fear.

All six of these alters continued to exist *outside* my body, in 'Around.' This meant that 'Beth,' who lived inside my body, had a reduced awareness of her immediate surroundings, because part of her consciousness had been pulled outside her. If someone snapped his fingers and said "Right," 'Beth' would step to the right, fade out, and the alter 'Rightie' would take over the body. 'Rightie' had no awareness of 'Beth' or what went on in the body when 'Beth' inhabited it. As this program was expanded to create further alters who lived two steps out from the body, then three, more and more of my consciousness was pulled out-of-body into 'Around,' and my spatial perception grew more confused. Even as an adult, identifying east or west, right or left, took careful thinking on my part, well into my recovery process.

Once a child's spatial perception has been carefully fragmented and pulled out-of-body, it becomes relatively easy to trigger switches in consciousness within the body. The child gradually reaches a point where she switches every time she changes physical direction – for instance, every time the body shifts to the left or right while playing tag on the playground, switches in consciousness are occurring, so that there is a constant blur of memory and focus. As a result, the child grows more confused, less self-reliant, and more responsive to external demands. This breakdown in spatial perception also enhances other types of switch programming that rely on physical realities, such as rainbow programming.

As a small child, I was taken to the foot of a large rainbow that had tracks running over it much like a midway ride. My birth parents would say goodbye to me and place me in the cart. The cart would physically take me 'over the rainbow.' On the other side, a different family stood waiting. They told me they were my new family and gave me a new name. While I lived with this new family (which might be as little as half a day), my birth family was never mentioned, and I was programmed for a new series of tasks. Once this had been accomplished, I would be returned 'over the rainbow' to my birth parents.

As the rainbow was used as a *physical* bridge of amnesia between more and more realities, it translated into verbal and visual cues. If I happened to remember something that belonged to another reality and mentioned it, my mother would quickly say, "That's over the rainbow, Beth," and I would be triggered to 'forget' or dissociate that consciousness. Soon I simply had to be shown a picture of a rainbow and I would 'forget' one reality and switch to another. (These rainbows could also be black and white, upside-down, or come in different color patterns.) Greeting cards that display rainbows are frequently used to reinforce 'forgetting.'

An intelligence cult member is also programmed to 'forget' or displace memory through common activities such as sweeping, shoveling, cleaning, throwing out the garbage, bathing, eating (poisoning the memories), and closing doors. External sounds, such as ticking on the wall, will trigger a shift in consciousness. For instance, a ticking on the wall to one's left will activate an out-of-body alter which exists to the left of the body. Modern technology can cause ticking sounds on a wall from a remote location, so that thousands of ticking sounds can be heard coming from every wall in a room simultaneously. This is an effective scatter/scramble program, intended to disorient the victim. The term 'tickyboo' is a common verbal trigger used to fragment and scatter consciousness.

As my physical reality became more fragmented and my consciousness was pulled more and more into 'Around,' I learned to dissociate quickly and reliably. Since my 'trainers' wanted to control my 'out-of-body' alters as well as my 'in-body' consciousness, they needed to program me to store memory fragments and alters in calculated structures. (Note: Forgetting is not losing memory, it is a storage process.) A basic storage structure frequently mentioned by survivors is the matrix, or derivatives thereof, such as the acoustic. A child will be shown a basic tic-tac-toe matrix, wherein each square has a number or letter, and told to store an alter in each square. An alternative to this is a hallway of color-coded doors with a room for each alter, or a dungeon with cells. These structures are layered according to frequencies – the more pain or trauma that is

applied to the body, the further 'out-of-body' the hallway or matrix into which the alter will project itself to 'live.'

The cross in the circle is one of the most basic storage structures. Each section is known as a quadrant. The two upper quadrants store alters at a white-light frequency. The

upper right side stores alters at positive 'happy' frequencies, the left side stores white-light alters traumatized by electric shock, or pins and needles (etc.). The lower half stores alters at dark frequencies, the left quadrant 'keeping' the traumatized frequencies, the right quadrant 'keeping' the positive ones. Cults, and society in general, constantly program us to limit our consciousness to the upper right quadrant (i.e., right = light = good = happy) and the lower left quadrant (i.e., left = dark = bad = terror). Common cult triggers link phrases such as 'good people,'

'children of light,' 'path of light,' and Christian terminology. Healing involves exploring the positive power of the dark as well as the trauma stored in one's white-light frequencies, and *dissolving* the cross.

Another basic storage structure is 'star programming.' Beginning in early childhood, electric shock was applied to my genitals to create 'stars selves,' which would then be arranged in constellations, even entire universes. I was usually prepared through a careful series of triggers. As I lay in my bed at bedtime, my father would tell me, "If you see Daddy tonight, it's just a dream." Then he would say, "You are rising, little Beth, lifting up out of your body. Keep going straight up. Up, go Up, and *there* you will find a room just like this one, with a bed just like this one. Now climb into that bed and go to sleep up *there*."

As I had been programmed to dissociate on verbal cue, I would lift out of my body, float upward and find the psychic dimension he had described. *There*, one of my father's dissociated alters would lean over, kiss me goodnight, turn out the

light, and leave the room. Meanwhile, down below in the 'real world,' another alter would be triggered to enter my body. This alter (who I will now refer to as 'me' or 'I') would then be led to the basement where electric shock equipment had been set up, and laid on an old wooden table with a bare bulb burning overhead. As I stared at the lightbulb's vivid burning wire, my genitals would be gently stimulated, triggering a state of arousal. I would then be shown a picture of a five-pointed star.

"Do you want to be a star?" my mother would ask. Stars were beautiful. They were white and pure and faraway. Who wouldn't want to be a star instead of a human body? "Yes, I want to be a star," I would reply.

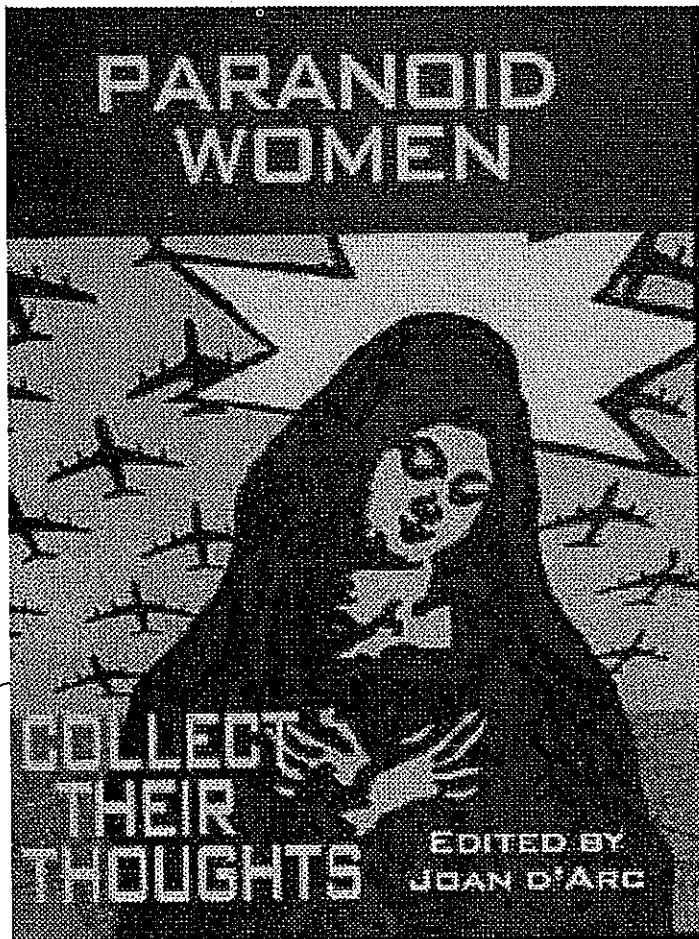
"You can be a star," my mother would say. "Just a second of pain, and then you'll be a star."

"Up Up Up Up Up," my father would cue, then apply shock to my genitals. Still in a state of arousal, I would leave my body as conscious sexual energy and travel upward to the 'fifth dimension' – the dimension past God, where the stars and planets lived. In this dimension, I felt no pain, only sexual arousal; but a pain barrier had been created between my 'star self' and my body – the memory of the electric shock that had been applied to my genitals. If my star self wanted to return to my body, or my body wanted to retrieve the energy and consciousness that had been imbedded in this particular star self, either one would first have to pass through the painful shock barrier that had been erected between them.

As I grew older, I was shown pictures of familiar and unfamiliar constellations and programmed to store star selves in patterns at different frequencies. Eventually many universes were created, including color stars and color universes. Planets inhabited by systems of alters became another means of storage. I was also shown pictures of spaceships and told to 'send' myself to them. Alters who ran these spaceships controlled the alters living in stars and planets, and reported to 'earth' or in-body alters, who then reported outside the body to trainers. Many of these 'outer space' alters traveled between planets and spaceships in 'beams of light,' and some looked like aliens. Star Trek imagery has been heavily incorporated into intelligence cult programming.*

the biological basis of elitism and “divine right” rule

On October 28th, 1998, a number of newspapers across the country ran an Associated Press article entitled “Presidential Hopefuls Share Blue Blood Lines.” The article, based on information put forth by Burke’s Peerage, claims that every single President of the United States has had a notable

amount of royal European ancestry, and in each Presidential race, the one with the most royal genes is the one who wins – every single time. This tendency has been noted in supposedly Democratic European politics as well, prompting some to charge that a global conspiracy exists to keep power within the hands of a specific gene pool.

This charge is not entirely baseless, and many books have been written tracing the modern aristocratic bloodlines back to the royal houses of Israel, Egypt, Sumer, and beyond. The charge is further supported by the fact that many of the supposed conspirators proudly boast about the ancient origins of their ancestry. The traditional explanation for why power is passed down through the ages by blood has been the mystical Divine Right of Kings. This dates back to the 17th century and states that a king is created by God, and kingly authority resides in the blood irrespective of anything else. Many have claimed that there is a genetic characteristic carried in the blood itself which makes this so, but what would it be? Is there a legitimate physiological reason behind the Divine Right of Kings?

fields of the nephilim

The all-important element of the Divine Right is that it comes from God, or “the gods,” alternately. And who were these gods? Authors such as Zecharia Sitchin, Sir Laurence Gardner and Nicolas de Vere are authoritatively convinced that kingship was created by an advanced race of beings called the Anunnaki, also called the Nephilim in the Old Testament. These were the ones who created the human race and interbred with a portion of it to create the kingly caste which until this day has still maintained control over the Earth.

These celestial creatures have been variously identified with Dragons, Elves, Fairies, Gnomes, Leprechauns, Sprites, Nymphs, Pixies, Angels, Demons, Devils, Witches, Giants, Vampires, Werewolves, and just about every mythical being you can imagine. Some, like Gardner and Sitchin, claim that they come from another planet. Others, like de Vere, say that they’re multi-dimensional, or that they’re from the Hollow Earth. Some, like David Icke, say that they are humans inhabited by the spirits of multidimensional reptiles, capable of shapeshifting into reptile form at any time. Still others claim that they were humanoid, but more than human, with pale white skin. The human hybrid offspring that they created as the Royal/Priestly caste was, according to most, the Aryans, who usually had red hair with green eyes – in stark contrast to the traditional Hitlerian vision. Nicolas de Vere, the leader of an organization called The Dragon Court which claims to represent this royal Aryan caste, writes, “the depiction of the Aryan (Scythian) as a tall, ruddy-complexioned blonde racist yeoman-farmer-warrior-god has no basis in truth.” He further suggests that the “yeoman-farmer” Celtic, Gaulish and Pictish

tribes which we now think of as Aryan were actually of a different race, but had hired the extra-human Aryans to be their leaders.

These Aryans were also the masterminds behind the Indian, Hittite, Greek, Egyptian, Hebrew, Sumerian and Pre-Sumerian Ubaid civilizations. Many believe that their descendants can be found amongst the segment of the population with the RH Negative blood type, roughly 5% of the Earth's population, most of them Europeans. These people are often born with an extra vertebra, have a lower than normal body temperature, and can rarely mate with one another successfully, which suggests that they may indeed be a hybrid species. Conspiracy enthusiast Arizona Wilder takes it a step further by stating: "The Aryan bloodline is alien to this planet... There are 13 bloodlines from this kind of stock (the Merovingians being one), and all of them have to a greater or lesser degree the capacity to play host to the Shape Changer reptiles."

The other 12 families have been identified as Astor, Bundy, Collins, Dupont, Freeman, Kennedy, Li, Onassis, Reynolds, Rockefeller, Rothschild, Russell, and Van Duyn, with the rest of the European Royal Families being categorized as Merovingian. These are the people referred to by the fanatical group, the Sons of Jared, when they "pledge an implacable war against the descendants of the Watchers, who as notorious pharaohs, kings and dictators, have throughout history dominated mankind... like super-gangsters, a celestial Mafia ruling the world." The Book of Enoch says that the sons of the Nephilim are destined to "afflict, oppress, destroy, attack, do battle and work destruction on the earth."

Nicolas de Vere, himself a Prince of the Dragon Blood, sees it quite differently. He sees them as the rightful shepherds of the human flock. He states:

The fairies were tuned to a higher frequency of perception and activity generally. In the past, therefore, because the Fairies were, for millennia, physiologically bred and exhaustively trained to operate at a higher level than men, humans often invited them to become social navigators... A dragon was one who saw clearly, and the clarity of vision engendered was always classically associated with wisdom, which itself produces power....

The Anunnaki and their quasi-human offspring are attributed with remarkable traits. They lived for thousands of years, were capable of levitation, dimension-hopping, clairvoyance, and other magical powers, all a product of applied eugenics. de Vere explains: "Selective unions gave the race the opportunity to breed outstanding magicians whose gift of natural perception and understanding and whose ability to access the 'Otherworld' helped to produce

and guide brilliant kings who ruled with elegant aplomb. The ability to perform magic was carried in the blood and of that blood," and "the Elves were relied upon by their client races to be able to see things and perform feats that these client races couldn't."

Laurence Gardner, himself a former member of the Dragon Court, concurs: "In short, these people were bred to be leaders of mankind, and they were both mentally and physically maintained in the highward state." But what property did they inherit in the blood which makes this possible? The experts are nearly unanimous about the fact that the answer is endocrinology. Says de Vere: "hormonal levels [are] influenced by genetic inheritance and that hormones [affect] the individual's perceptions, psychological unicameralism and the subsequent ability to transcend and perceive the intricacies of the cosmos. Elven blood [is] rich in these substances."

starfire bloodfests

"The best blood is of the moon, monthly..." Aleister Crowley, *The Book of the Law*.

The beneficial effects of the hormone melatonin have been part of the health supplement scene for some time, for high melatonin production is known to be synonymous with a high immune system, a low cancer risk, long life, energy, stamina, and according to many, enhanced spiritual awareness. Perhaps it is fitting then that this hormone is secreted by the pineal gland, a mysterious little item long believed by mystics to be the "Seat of the Soul," "The Third Eye," and the organ through which psychic powers are exercised. In fact, it actually functions as an organ of sight in some reptiles, and it still seems to possess some sensitivity to light in higher mammals, since melatonin production increases when the person is exposed to darkness (thus melatonin means "night worker.") Writes Laurence Gardner:

High melatonin production thereby increases the facility for receiving and transmitting high-frequency cosmic and local broadcasts, and leads to a greater state of cosmic awareness - a state simply of 'knowing.' In this regard, it is interesting to note that the Pineal Third Eye has been found to contain very fine granular particles, rather like the crystals in a wireless receiving set.

Many magical rites and meditation techniques are aimed at gaining control of this organ and the fluid it produces: the live melatonin. Rumor has it that the members of the super-secret society Skull & Bones, to which both George Bush and his son belong, engage in a ceremony called "The Obscene Rite," which involves the consumption of the live pineal gland of a human or animal sacrifice in order to get the fresh secretions. Supplements bought over the counter are ineffective because, as Gardner explains, "their inherent secretions are obtained from the desiccated glands of dead animals and they lack the truly important elements which only exist in live human glandular manufacture."

But the Aryan overlords who ruled over mankind in ancient days had a simpler way of acquiring this fluid. Their ancestor-gods, the Anunnaki, had endocrine systems that produced large amounts of this and other beneficial substances, so they drank it straight from the source: the menstrual blood and vaginal

fluids of the goddesses themselves. This they referred to lovingly as "Starfire" and drank in a ritual ceremony called the Black Mass, after which the Catholic Mass is said to have been modeled. Later, as direct contact with the Anunnaki ceased, the fluids were collected from sacred priestesses referred to as "Scarlet Women," or "Grail Maidens."

Readers will recognize the Scarlet Woman as the Whore of Revelations, as well as the title which Aleister Crowley gave to all of his sex magick partners. "These sacred, royal princesses," writes de Vere, "virgins of High Birth and Pure Blood, at an optimum age would be chosen to act as feeding females," whose essences contained such valuable substances as, "oxytocin, prolactin, melatonin, sera-

tonin, adenosine triphosphate, dopamine, telomerase, and retinol." There is another important ingredient in the mix here. De Vere explains, "many think that only men have semen when in fact women also have it." And so a Starfire ritual involves the use of a golden straw.

Such a device would have been inserted into the virgin's urethra to the depth of about one inch, whilst the partner in the rite inserted his or her finger into the vagina and massaged the "roof of the mouth" or uppermost wall of the canal nearest the open or 'mouth' of the vagina, behind the pubic bone. After a few conducive moments perhaps, orgasm would occur and the fluid from the gland would discharge itself through the straw, either into the waiting mouth of the recipient, or onto a "grail platter" or dish held next to the vulva.

Keen readers will recognize this as identical to a sex magick ritual advocated by Aleister Crowley for members of his Order of Oriental Templars (OTO). The only difference is that his rite also involved the use of male semen which was called the "Red Tincture" or "coagulated blood," while the female fluids were called "Gluten" or "The White Tincture." Together they made "The Elixir of Life," and in alchemy blood and semen are the *primae materia* or first matter of the great work. "This is the true Key to Magick," writes Crowley. "That is, by the right use of this secret man may impose his Will on Nature herself."

monatomic gold: the substitute

According to de Vere and others, ingesting the fluids of mundane women has only a slight effect, certainly not enough to maintain a royal Dragon family in the manner to which they're accustomed. And after a few thousand years the genetic purity of their Grail maidens began to deteriorate, so the Starfire lost its potency. This reportedly began around 1960 BC and is equated with the time that an edict was handed down to Noah by God demanding that the consumption of all blood cease immediately. (Gen. 9:4) Thus, a substitute had to be found, and so the alchemical process was created as a means of artificially creating the Elixir of Life, the Philosopher's Stone, also known as "potable gold." This is created using a black powder known as occulum, the universal solvent which has the power to transmute metals. When placed against gold it converted it into a white powder which could be ingested. It is said to cause nothing less than immortality, as it sets off a self-correcting mechanism in your DNA that lasts for thousands of years. It also bestows the enhanced melatonin production and magical powers associated with Starfire, including clairvoyance, dimension-hopping and flying capabilities. It is believed that this "white gold" is the same as the "Shew-bread" and "Manna from Heaven" mentioned in the Old Testament.

Today, there are those who publicly proclaim knowledge of the Philosopher's Stone. A man named David Hudson claims to have created a technique for manufacturing this white gold, which he's patented as ORME (Orbitally Rearranged Monatomic Elements). Ormus is a name associated with the Holy

Grail, and so readers may not be surprised to learn that Hudson himself is related to the Merovingian Grail family through Claude de Guise. Basically, the powder is created by putting gold into a higher atomic state through a series of intense heating and cooling sessions, during which it loses and gains weight radically, as though portions of the mass were being transferred into another dimension. David Hudson describes the magical quantum properties of his white gold:

These M-state elements have been observed to exhibit superconductivity, superfluidity, Josephson tunneling and magnetic levitation... They may enhance energy flow in the microtubules inside every living cell. Ingesting m-state gold has different effects on the body than the effects of ingesting metallic gold. At 2 mg. it totally has gotten rid of Kaposi Sarcomas on AIDS patients. Within 2 hours, their white blood cell count goes from 2500 to 6500. ... Stage 4 cancer patients have taken it orally, and after 45 days have no cancer left any place in the body. It's been used on Lou Gehrig's disease, it's been used on MS, it's been used on MD, it's been used on arthritis. It literally corrects the DNA.

sympathy for the devil

All of this puts a nice, friendly face on the whole thing, which is currently a secret power held only by an elite caste of Aryans who use it to lord themselves over the rest of the human population. And there are those who have said that the "substitute" white gold never did away with the original practice of blood-drinking as a method for obtaining the substances they needed. David Icke and his associate, Arizona Wilder, have campaigned the globe to inform its citizens with Chicken Little-like hysteria that most of its financiers, politicians and aristocrats are actually under the control of Reptilian beings from another dimension, who are inhabiting their bodies. Icke states: "To hold their human form, these entities need to drink human (mammalian) blood and access the energy it contains to maintain their DNA codes in their 'human' expression. If they don't, they manifest their reptilian codes and we would all see what they really look like."

Icke believes that most of this blood is obtained in human sacrifice rituals engaged in by the Satanic Illuminati. He explains: "From what I understand from former 'insiders', the blood (energy) of babies and small children is the most effective for this, as are blond-haired, blue-eyed people. Hence these are the ones overwhelmingly used in sacrifice, as are red-haired people also." His compatriot, Arizona Wilder, goes into a bit more detail when she writes, "They have a hypnotic gaze which fixes the victim - in a

trance of terror - which promotes secretion of the pineal gland - at that point, they cannot hold human form any longer and begin to shapeshift in anticipation of supper."

Wilder claims to have witnessed Laurence Gardner drinking blood and shapeshifting during a sacrifice at Montauk, New York, as well as a number of others who were transformed during similar bloodfests, including, "Bush and his two sons, Albright, Kissinger, Reagan and Nancy, J. Rockefeller, Ford, Carter and LB Johnson, Queen Mum, Queen Liz II, Princess Margaret, Charles, Tony Blair, Prince Philip, and Zecharia Sitchin." She acknowledges that Starfire rituals go on as well:

In the underground vaults of his castle in the Alsace Region of France, green glowing fluorescent rocks turn stored menstrual blood black to be used at that special ritual. All the British House apparently have jewel-encrusted goblets to drink the blood from the symbolic female grail and a symbolic dagger to give it a bit of a stir. Some Spencers were at these rituals, but Diana would not attend... the smell of Diana's periods would have caused Charles to shapeshift - especially whilst sleeping because the reptiles cannot retain their human form without concentration.

This may shed new light on Prince Charles' reported desire to become a tampon. Aware of these charges, Laurence Gardner and Nicolas de Vere have tried to clear the record. They've acknowledged that vampirism does take place at their rituals, but maintain that they only drink the blood of their own family members, who participate willingly. "You cannot take the essences by force, they are only given in love," he says, otherwise, "their systems will react by producing chemicals during one's assault upon them that will completely knock out the chemicals traditionally required." They claim that vampirism was originally the purview of a few noble families who practiced it in order to maintain their powers.

"The most famous stories," writes de Vere, "those of Dracula, Bathory and de Rais, support this conclusion." He and Gardner enthusiastically embrace Dracula as one of their own: "This Sacred Prince, a Hemic scholar and initiate, a student of magic, Magus, Witch Lord and Dragon Prince, counterbalanced the bloodlust of his forebears with a refined knowledge and advanced practice of Grail procedure." This is because he was a member of Sigismund's Dragon Court in Hungary, and therefore of the Grail blood, who also attended a hermetic academy called the Austrian School of Solomon. "The orthodox establishment's fear of Dracula," writes, Gardner, "was not his treatment of enemies but his in-depth knowledge of alchemy, kingship and the ancient Star Fire customs."

As for the claim that they use these rituals to conjure up dragon ancestors from another dimension, de Vere calmly admits that this is the case, and that the participants have their bodies taken over by these spirits, who "rise from the dead to take possession of the witch's soul!" He further explains:

Any spirit, including the archangels, conjured by the witch or magician was actually the ancestor of the witch. ...It was carried in the witch's blood which, the purer it was

through the unbroken descent from the Dragons, the stronger would be the return from the ancestors within. In other words, they brought together and spoke or gesticulated a series of mnemonics that would trigger off precontrived, imprinted states of consciousness that acted as doorways into deeper seats of consciousness.

The charge of Satanism is not entirely refuted either, but de Vere proffers that they are not worshipping Satan so much as honoring one of their forefathers, who they stick right in the family tree along with Jesus, David and the rest. "The Sabbatical Goat of the Black Mass was Chem Zoroaster," he writes, "one of the early ancestors of the ancient Dragon Families," and, "Satan was also called by the witches 'Christ, son Dei.' ...Jesus' heredity and the descent of the druidic dynasties... was devilish, because the descent of both bloodlines was from the Sumerian Enki who was the Akkadian Samael: the Roman Lucifer and thus the Catholic Satan." But the Dragon Court members make no apology for this, because, "to any intelligent person, to any true seer, concepts like white or black magic or good and evil are irrational, childish nonsense; both in terms of logic and actual fact."

every elf for himself

"*This is our Law, and the Law of the Strong.*" -- Crowley, *ibid.*

To the charges of "conspiring to take over the world," the Dragons deny that they give two licks what the rest of humanity does with itself. Their primary concern is "the restoration of their own Tribes, their own Nation and their own Homelands... the foundation of their own distinct society...re-introducing their old social structures and values." This results in "The Grail Code," a system of Egalitarian, Chivalric ethics that govern how dragons treat other members of their race. However, "it is not the code that efficiently orders the behaviour of the Dragon Families in their dealings with those not of the Grail Blood." They acknowledge and defend their own elitist attitudes towards mankind, whom they regard as "thoroughly stupid and dim-witted, with a clear indication that this condition is genetically inherited." Whereas in contrast, "The Elves were naturally transcendent of spirit and their queens and kings were insulated from the common round of nuisances and petty concerns by minds which were bred for deeper matters."

Despite their hatred of humanity, they will kindly agree to be the guardians of our governments again (if they aren't secretly doing so already), should the population choose to accept them, and offer them the thrones of the Earth, which de Vere and friends indicate are rightfully theirs anyway. They are just waiting for mankind to realize it again. We will have to deal with the fact that these "Elves" seem to be in possession of a material that bestows long life as well as fantastic physical, mental, and spiritual powers, giving them a distinct advantage through which they are clearly attempting to lord over us, while they allow our populations to wallow in disease, death, and spiritual degradation. As an excuse, de Vere and Gardner claim that the Starfire and White Gold are only effective for those already of the Dragon Blood anyway, because the rest of us "won't have the right blood serum or the right connections in their cerebral lobes."

De Vere denies the claims of most people who believe themselves to be of this bloodline. "Some people argue that because of the outbreeding of the old families, there must be millions of people 'of the fairy blood' living today: but such a statement flies in the face of

accepted facts of history. The genuine old royal families rarely outbred at all, whilst the later, fake parvenu, tinker nobility whom people now confuse with them often did." So that leaves little hope for you and me of ever obtaining the fruits of this magnificent "Philosopher's Stone," which "gives youth to the old" and is described as "the summation of the heart's desire." And if such a substance were available to the public, how much would it cost? Would it be obtainable by everyone or only the rich and privileged? What if it could be administered for free in the water supply or was available in tablet form at your local pharmacy, covered by your health insurance policy? What would happen to our already exploding population?

As a species, mankind will have to decide how to deal with the information -- provided that the information is aired in public some-day, and provided our "thoroughly stupid and dim-witted" populace can figure out what to do with it. Will we take advantage of what could be our greatest opportunity to advance as a species, or will we allow it to be used against us by a caste of Aryan overlords who despise us (and who are literally the spawn of Satan!) Then again, will we perhaps wish to accept their rule, and the benefits of being led by an advanced race whose powers and insight are greater than our own. After all, there are those who believe that civilization is created by and can only be maintained by an established elite. Would we want to meddle with that, and allow positions of power to be overrun by inferior men? Perhaps it is worth considering whether an elite can truly be made by enhancing human faculties, or whether such powers are purely in the blood.
